**UTILITY EASEMENT**

THIS EASEMENT is granted this \_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by the City of Winner of 325 S. Monroe Street, Suite #118, Winner, SD 57580 being the current Owner of the below described real estate near the City of Winner, Tripp County, SD to the City of Winner, South Dakota (City).

WHEREAS, the City will construct and maintain sanitary sewer, electrical power lines and equipment, and water main over, under, and upon the land belonging to the Owner, and the Owner will cooperate with the City in the construction of said drainage intakes and storm sewer to its mutual benefit.

NOW THEREFORE, in consideration of the construction and maintenance of said sanitary sewer, electrical power lines and equipment, and water main by the City, the Owner grants to the City the perpetual right and easement to construct, maintain, and repair said sanitary sewer, electrical power lines and equipment, and water main over, under, and upon a permanent utility easement as described in the following:

Utility Easement – A 1,500 +/- SF parcel described as the East Ten Feet (E10') of Lots Eight (8), Nine (9), and Ten (10), Block Forty-one (41), First Addition to the City of Winner, Tripp County, South Dakota.

This grant is subject to the following conditions:

1. The sanitary sewer, electrical power lines and equipment, and water main shall be constructed in a good and workmanlike manner, and all disturbed area shall be restored to a finished grade similar to that now existing, per plans and specifications, and seeded to grass.
2. The City will save the Owner harmless from any claims for damage arising out of the construction and maintenance of the sanitary sewer, electrical power lines and equipment, and water main.
3. The Owner will maintain the surface area of the easement following construction. The Owner will keep the easement area clear of any structure, debris, trees, shrubs, or landscaping whatsoever and not impede surface drainage or drainage flow paths.
