## CHHA JOB DESCRIPTION

Reporting Structure: Reports directly to the Nurse Supervisor

## Qualifications:

- 1. Holds a current certificate as a CHHA issued by the New Jersey Board of Nursing.
- 2. Cleared background check with good record standing.

## **Duties & Responsibilities:**

- 1. Maintains a safe environment for the client.
- 2. Provides or assists with full or partial bath in the bed or in the bathroom (tub baths or showers may only be given with approval from the RN).
- 3. Assists with client's personal grooming, including care of hair, teeth and mouth, dressing, shaving (with electric razor only) and nail care. NO CUTTING OF NAILS.
- 4. Prepares and serves meals according to the client's dietary requirements and assists clients with feeding.
- 5. Assists clients on and off the bedpan, commode or toilet. Ensure regular "turning" of "bed bound" client to prevent bed sores. Demonstrate appropriate skin care techniques.
- 6. Assists clients with walking and with transfers from bed to chair or wheelchair. The Nurse supervisor will assess transfers for both client and employee safety.
- 7. Assists with pre-poured medications ordered by the doctor. CHHAs, by law are not permitted to dispense medications from a prescription bottle. They may remind clients to take their medication or hand them to a client if the medication is in a "pre poured daily/weekly medication dispenser".
- 8. Follows orders and keeps simple records as instructed by the RN.
- 9. Record all pertinent information on the activity sheet accurately and in a timely manner.
- 10. Carry out necessary light housekeeping duties including dusting, bed making, dish, washing within kitchen and relevant cleaning within bedroom, bathroom and /or living area.
- 11. Accompany client to medical visits, e.g. hospitals or Physician Office. **Note:** CHHAs are not permitted to drive clients. Emergency transportation must be done by ambulance.
- 12. Complete errands to grocery store, pick up medications etc., as requested by client.
- 13. Carry out personal laundry functions only for the client.
- 14. Adhere in Universal Precautions, aseptic techniques and infection control guidelines.
- 15. Demonstrate the ability to communicate with the client, his/her family member or representative.
- 16. Provides socialization, comfort, company, empathy and support for the client.
- 17. Adhere to policies regarding confidentiality as per Agency protocols.
- 18. Ensure hours and attendance information is recorded and reported in a timely manner as per Agency protocols.
