# Design of a New 'Action Sports Park' in Wheaton Regional Park Will Be Focus of Virtual Meeting on Wednesday, April 3



Montgomery Parks is in the early design stage of a new “Action Sports Park” at the Rubini Athletic Complex in Wheaton Regional Park. Two design concepts will be shared at the virtual community meeting from 7-8:30 p.m. on Wednesday, April 3. The goal of the Action Sports Park will be to deliver safe, inclusive and engaging action sports experiences that serve a diversity of ages and skill levels from beginner to advanced.

## *In pending development news...*

### **Glenmont Forest Apartments Redevelopment**

The Glenmont Exchange invites you to our **April 11th community meeting** with the team helping to plan the redevelopment of the Glenmont Forest Apartment site. The meeting will be held at 6:30 PM at the Poplar Run Clubhouse, 13500 Stargazer Ln, Silver Spring, MD 20906. This will be an in-person meeting. If you plan to join us, please RSVP [here](#). While an RSVP is not required to attend, it helps us plan the event. The RSVP asks for your name, the Glenmont area neighborhood, association, or business you represent (or live in), and your email address so we can more easily reach you if there are event updates.

That complex is behind the police station in the southeast corner of Georgia and Randolph. While this is just a Forest Conservation Plan, not a Site Plan, it appears that the project will replace the aging garden apartment complex on the site. The developer is proposing that 15% of the units will be MPDUs. As with all redevelopments, the site will have much higher density after the proposed redevelopment. While planning for the redevelopment remains in its early stages, the team plans to talk about how their current plans address the recommendations of the 2013 Glenmont Sector Plan for redeveloping the site.

## Glenmont Corridors Opportunity Study

The team at Montgomery Planning presented the scope of work for [the Glenmont Corridors Opportunity Study](#) to the [Montgomery County Planning Board](#) at its March 7 meeting. The purpose of the study is to identify actions necessary to support Thrive Montgomery 2050's principles of corridor-focused growth, complete communities, and 15-minute living in the study area.

The study will also evaluate which recommendations from the 2013 [Glenmont Sector Plan](#) have been achieved, identify the barriers that are preventing recommendations from being implemented, and identify strategies to further Glenmont as the walkable, diverse, and sustainable community envisioned in the 2013 Plan.
