## **Identity History Summary Request Form**

Complete all required fields of the attached Identity History Summary Request Form. The applicant's first name and last name are required. Please use your surname or "family name" for your last name. Use your "given name" as your first name and if you have more than one middle name, please list them in separate fields.

The applicant's Date of Birth, Place of Birth and Country of Citizenship are required. Applicant must indicate if they are a U.S. citizen or Legal Permanent Resident (green card holder). If you are not a U.S. Citizen or Legal Permanent Resident, you must order your report directly from the FBI. The applicant's full US home address is required. This includes the street address, city, state, postal or zip code and country. A report cannot be shipped to international address per FBI regulation.

Home phone number and email address are not required, but are helpful if we need to contact you about your order. An email address is necessary to receive secure website access to completed report. We encourage you to include this information, if available.

### **Order and Disclaimer**

Please select your order options for additional report copies, if any, and delivery method. Please enter your order total on the "Total FBI Report Payment" line of the Order and Disclaimer form. This should include the base report fee, premium shipping fee, if any, and the total cost of additional copies of the criminal history report.

Only Visa, MasterCard, American Express, Money Order, or Cashier's Check are acceptable forms of payment. Cash, Personal check or Business check will not be accepted. No charge backs or refunds / All sales final.
