## Quick Start Guide

### Step 1:

[CLICK HERE](#) to create a BlueNotary account

Be sure to choose “Notary” as your account type when prompted

### Step 2:

Once you are logged into the homepage, you will see three Getting Started onboarding tiles at the top of the home page:

RON approval document, Stripe Payout Details, and Notary Profile.

**The RON approval Document** is the letter/email/certificate that will show you that you approved to do RON from your SOS. Upload a copy of this document.

**Stripe Payout Details-** Stripe is the payment processor that we use to pay you out for doing work on the platform. We also have an invoicing integration with Stripe for our Notary Pro members to invoice their clients and be paid directly through Stripe. Stripe is free to set up if you do not already have an existing Stripe account.

**Notary Profile Details-** Enter your full name exactly as shown on your commission (include your middle name or initial beside the first name if shown on your commission), the state you are commissioned in, your commission number, and your commission expiry date.

If you do not have a commission number, please enter N/A.

If you do not have your commission expiration date, please enter a future date for now. This can be updated later.

Once all these steps are completed, your account will be under review and will be approved within 24-48 hours. If it exceeds that, or you wish you have your approval expedited, feel free to reach out to [joey@bluenotary.us](mailto:joey@bluenotary.us).

Your E-seal and digital certificate will automatically be generated for you to use on the platform, and are free with your Notary Pro plan.(View your E-seal under your manage tab)
