

Whenever adjunct professor Elaine Wright meets a student who's been a notary for years, her first thought is, "uh-oh."

"That's because I'm sure the person hasn't been trained properly," said

Wright, who teaches courses on various notary subjects at Prince George's Community College. At the end of her classes, those longtime notaries often express thanks and appreciation because they just didn't know many of the proper skills, she said.

Wright, who lives in Mitchellville, says notaries do more than just stamp documents: They help protect the community from fraud. As a notary signing agent, Wright works hard to educate notaries, increase the field's professionalism and serve the public with care. For her hard work and dedication, the National Notary Association recently honored Wright as its 2009 Notary of the Year.

"I was elated when I found out I'd won because I'm passionate about what I do," said Wright, who became a notary in fall 2002. In addition to gaining a new skill, Wright teaches and empowers others. Further, she serves as a mentor in the profession by constantly speaking at national conferences and developing her expertise.

At the community college, Wright works with students who need retraining for their jobs or who want to transition into a new field. Notary signing agents such as Wright, for instance, can assist homeowners who are refinancing their homes. That particular line of work often interests retirees who need supplemental income, although the field has taken a hit during the current mortgage crisis.

Wright teaches all these students

how to take their role seriously. The state of Maryland has about 87,000 notaries, she said. By serving the public, these professionals can deter mortgage fraud and help prevent identity theft. But they must know how to do their jobs properly.

"You never know when someone might challenge you," she said. "If the notary can't verify something, he or she could be in hot water."

Wright recalled a client who showed her a passport that didn't look correct.

"The picture was raised, but in passports pictures are embedded," she said, adding that the passport also lacked a signature. "I just courteously asked the person to bring back another type of ID."

She provides notarizations for friends, co-workers and the general public, and she never charges for those tasks. She only charges for loan documents. Wright further assists the community by serving as an election judge, as well as managing the Web site and editing the newsletter for her community civic association.

Her next goals include publishing a book on notary public procedures and learning more about e-notarizations, which require notaries to use electronic notary seals for electronic documents.

"Technology is just taking over," Wright said.

WASHINGTON – September 21, 2009 – “Ushering in a new era of efficient and secure delivery of legal judicial orders, the Honorable John M. Facciola, Magistrate Judge for the U.S. District Court in the District of Columbia, has issued the first digitally signed judicial order in U.S. history.”

“A judge signs his or her name many times each day,” said Facciola, who issued the first digitally signed court order on Aug. 26 at 12:08 p.m. Eastern Standard Time. *“The capability to sign electronically an order or other document should create in the people who see it an assurance that the document was signed by the judge and eliminate corrupt attempts to use forged, electronically created documents for improper ends.”*

A Notary Public has more powers than the Justice of the Peace. Justices of the Peace are limited to notarizing certain types of documents such as affidavits. Notaries Public have the power to notarize documents such as wills, deeds of trust, including documents going out of the country”*.


