By 4:00 p.m., she learned that the school required her daughter's signature, but her daughter was out of state. Navigating the enrollment process can be challenging, and her grandson faced several potential obstacles that could have delayed his start. Fortunately, the ability to notarize documents remotely allowed her to address an urgent need in an efficient and timely manner. The remote online notarization process saved her time and alleviated the pressure of ensuring everything was in order for her grandson to start school on schedule.
