We've been informed that the 460watt Jinko Solar panel that we used as our basis of design has been discontinued. We plan to issue revised basis of design drawings on 8/28 using the attached panel and inverter as the basis of design, since this panel's physical size has impacts to the spacing of rows of panels on the roof, as well as the string configuration. The new basis of design panel and inverter is attached.
