Ms. Bilderback wanted to know why the closest station to her house is not next on mutual aid. Chief McCann indicated there are a number of factors to determine the order of mutual aid. Below are two of the top reasons;

- 1. how fast a station can get on scene
- 2. the equipment needed on the scene

Hartford Fire is voluntary so that would move them down the list. Ms. Bilderback asked if Hartford Township Trustees have come to the fire department to ask for coverage or possibly joining the District. Chief McCann said no, but would be interested in Hartford joining the District. Mr. Stewart said COJFD is open for discussion with Hartford Township.
