A regular meeting of the Central Ohio Joint Fire District Board was held on Wednesday, July 17, 2024, at the firehouse located at 5138 Columbus Road Centerburg, OH 43011. The following attended:

Mr. Stewart called the regular Board meeting of the Central Ohio Joint Fire District to order at 7:01p.m.

HONOR FLIGHT PRESENTATION

Chief McCann introduced Honor Flight Representatives and shared information about the successful Mother's Day Flower Sale, held at the firehouse, in which all proceeds collected went toward Honor Flight Columbus. All in attendance watched a short video presentation about the Honor Flight Columbus program. Executive Director Beth Johnson shared information about the organization, which is a nonprofit organization dedicated to honoring America's veterans with a trip to Washington DC to visit their service and war memorials. They strive to help veterans share their stories with future generations, as well as celebrate their service to our country with a proper homecoming that many of them never received. With the conclusion of the 2023 flight season, they have successfully flown 128 missions that totaled over 9,300 veterans. The organization is funded entirely by donations from various businesses, foundations, school organizations, and other grateful Americans. Ms. Johnson thanked all for their hard work.

Chief McCann introduced Durena Holobaugh, coordinator and sponsor for the Honor Flight Columbus benefit, *Never Forget Cruise In*, held on May 11. Ms. Holobaugh shared information on the event, which raised \$8,125. Checks were presented to Executive Director Johnson.

Chief McCann presented Bill and Durena Holobaugh with a Certificate or Appreciation for their dedication to the *Never Forget Cruise In*.

LARRY HILES, PREACHING MINISTER AT MILFORD CHURCH OF CHRIST

Chief McCann introduced Larry Hiles, Preaching Minister at Milford Church of Christ. Minister Hiles had reached out to Chief McCann previously, interested in lending his support to the department. He has been through crisis training and received his Masters of Divinity from Liberty University. Chief McCann recommended the board hire Minister Hiles as Volunteer Chaplain for the Central Ohio Joint Fire District (COJFD), with the primary purpose of offering additional mental health support to the firefighters. In his volunteer role, he would need access to the building and permission to go on runs. Mr. Stewart made a motion to hire Larry Hiles as Volunteer Chaplain, and Mr. Cochran seconded the motion. Grant information shared as presented in Chief McCann's report. The Ohio Ambulance Impact Grant, obtained with the help of Lt. Andrian, will be the largest single grant in twenty-five years, in the amount of \$105,794.00. This was applied for to assist with pay raises and must be used specifically for employee pay and retention.

On Chief McCann's recommendation, Mr. Stewart made a motion to hire Daniel Ellinger to PART-TIME FF/Paramedic at \$19.00 per/hr. and serve a one-year probationary period and pass all background requirements. Should Daniel Ellinger be promoted, he would serve one additional year of probation, effective July 17, 2024. Mr. Dickerson seconded the motion.
