# CENTRAL OHIO JOINT FIRE DISTRICT BOARD MEETING MINUTES June 19, 2024

A regular meeting of the Central Ohio Joint Fire District Board was held on Wednesday, June 19, 2024, at the firehouse located at 5138 Columbus Road Centerburg, OH 43011. The following attended:

Mr. Stewart called the regular Board meeting of the Central Ohio Joint Fire District to order at 7:02 p.m.

## **PUBLIC PARTICIPATION**

### APPROVAL OF MINUTES

Mr. Stewart moved to approve the minutes from the regular meeting on May 15, 2024, and Mr. Dickerson seconded the motion. In the affirmative: Mr. Cochran, Mr. Dickerson and Mr. Stewart. In the negative: None.

### **ACCOUNTS PAYABLE**

Mr. Dickerson moved to approve the warrants presented, and Mr. Stewart seconded the motion. In the affirmative: Mr. Cochran, Mr. Dickerson and Mr. Stewart. In the negative: None.

Ms. DeCosky presented the monthly bank reconciliation; fund status ledger, appropriation ledger; receipt ledger and payment register for the Board's review and approval.

#### **REPORTS**

*Chief McCann Report* – (Attached)

Chief McCann updated the board on the Table Rock Estates, the 16-lot development planned on Wilson Road in Hilliar Township. The developers have not submitted drawings to COJFD, nor do they have a permit from the Environmental Protection Agency (EPA), to date. Chief McCann expressed his concern that the County is more interested in adding the housing than ensuring a safe community. He stressed the importance of the development being built with COJFD apparatus in mind, in order to ensure emergency access to future development residents.

The 2024 Budget Hearing will be held on July 17, 2024, at 7:00 p.m. with the regular meeting immediately following.

Chief McCann shared information on the partnership between the Red Cross and COJFD, *Smoke Alarms Save Lives!* Smoke alarms are offered door to door. A door knocker is left with the contact number for the Red Cross if the resident is not home. The Red Cross records distribution details. The goal is to distribute the smoke alarms throughout the Village and then the Townships.

Mr. Stewart moved to discard one workout bench (INV Tage #0532) due to it having no further use or value. Mr. Cochran seconded the motion. In the affirmative: Mr. Cochran, Mr. Dickerson and Mr. Stewart. In the negative: None.

On Chief McCann's recommendation, Mr. Dickerson moved to hire Hayden Normann as part-time firefighter/EMT-A at \$17 per hour and serve a one-year probationary period, effective June 12. Should Hayden Normann be promoted, he would serve one additional year of probation. Mr. Cochran seconded the motion. In the affirmative: Mr. Cochran, Mr. Dickerson and Mr. Stewart. In the negative: None.

On Chief McCann's recommendation, Mr. Stewart moved to offer a part-time paramedic position to Daniel M. Ellinger at \$19 per hour. Mr. Cochran seconded the motion. In the affirmative: Mr. Cochran, Mr. Dickerson and Mr. Stewart. In the negative: None.

## 5.925 LEVY DISCUSSION (EXPIRING 2024)

Chief McCann referred to the levy section of his report and discussed possible alternative sources of funding. He shared that COJFD has had continuous improvement in the past 5 years, both in community safety and capital improvements. His expressed his concern that if the levy was not replaced, the department would quickly lose that growth.

Mr. Cochran shared, for the Board's consideration, that he had reached out to voters and felt that of those he spoke to, most were not in favor of a replacement but may vote yes for a renewal. He expressed that whatever decision the Board come to, good communication with the public on the necessity of the levy would be critical.

Mr. Stewart shared that due to the cost of everything being higher, the levy must be replaced in order to sustain the fire district. As a board member, he did not want to put any resident in more financial strain and said there would have to be a limit at some point. However, he felt that a replacement of the 5.925 mill levy was necessary.

# MR. TOM STEWART MOVED THE ADOPTION OF THE FOLLOWING RESOLUTION: **PREAMBLE**

WHEREAS, THE LEVY WOULD BE FOR THE PURPOSE OF(*I*) For providing and maintaining fire apparatus, mechanical resuscitators, underwater rescue and recovery equipment, or other fire equipment and appliances, buildings and sites therefor, or sources of water supply and materials therefor, for the establishment and maintenance of lines of file-alarm communications, for the payment of firefighting companies or permanent, part-time, or volunteer firefighting, emergency medical service, administrative, or communications personnel to operate the same, including the payment of employer contributions required for such personnel under section 145.48 or 742.34 of the Revised Code, for the purchase of ambulance equipment, for the provision of ambulance, paramedic, or other emergency medical services operated by fire department or firefighting company, or for the payment of other related costs; pursuant to Revised Code 5705.19(*I*);

SAID PURPOSES BEING AUTHORIZED BY R.C. 5705.19 (I); AND,

# WHEREAS, A RESOLUTION DECLARING THE NECESSITY OF LEVYING A REPLACEMENT

TAX, PURSUANT TO R.C. 5705.19(I), OUTSIDE THE TEN-MILL LIMITATION MUST BE APPROVED AND CERTIFIED TO THE KNOX COUNTY AUDITOR ("AUDITOR") IN ORDER TO PERMIT THE BOARD TO CONSIDER THE LEVY OF SUCH A TAX AND MUST REQUEST THAT THE AUDITOR CERTIFY TO THE BOARD THE TOTAL CURRENT TAX VALUATION OF THE TOWNSHIP, AND THE NUMBER OF MILL(S) REQUIRED TO GENERATE A SPECIFIED AMOUNT OF REVENUE, OR THE DOLLAR AMOUNT OF REVENUE THAT WOULD BE GENERATED BY SPECIFIED NUMBER OF MILL(S).

#### RESOLUTION

NOW THEREFORE, BE IT RESOLVED, BY THE BOARD AT LEAST TWO-THIRDS (2/3) OF ALL THE MEMBERS OF THE BOARD CONCURRING, AS FOLLOWS:

- 1. THE AMOUNT OF TAXES THAT WILL BE RAISED WITHIN THE TEN-MILL LIMITATION WILL BE INSUFFICIENT TO PROVIDE FOR THE NECESSARY REQUIREMENTS OF THE TOWNSHIP.
- 2. IT IS NECESSARY TO LEVY A TAX IN EXCESS OF THE TEN-MILL LIMITATION.
- 3. PURSUANT TO R.C. 5705.03 (B)(1):
