#### CENTRAL OHIO JOINT FIRE DISTRICT BOARD MEETING MINUTES September 19, 2024

A regular meeting of the Central Ohio Joint Fire District Board was held on September 19, 2024, at the firehouse located at 5138 Columbus Road Centerburg, OH 43011. The following attended:

Mr. Stewart called the regular Board meeting of the Central Ohio Joint Fire District to order at 7:00p.m.

#### APPROVAL OF MINUTES

Mr. Cochran moved to approve the minutes from the regular meeting on August 21, 2024, and Mr. Dickerson seconded the motion. In the affirmative: Mr. Cochran, Mr. Dickerson and Mr. Stewart. In the negative: None.

# ACCOUNTS PAYABLE

Mr. Stewart moved to approve the warrants presented, and Mr. Dickerson seconded the motion. In the affirmative: Mr. Cochran, Mr. Dickerson and Mr. Stewart. In the negative: None.

Ms. DeCosky presented the monthly bank reconciliation; fund status ledger, appropriation ledger; receipt ledger and payment register for the Board's review and approval.

#### TRGC HOLDINGS, LLC DISCUSSION

There had been concern of TRGC Holdings' newly developed road in the district not meeting the Ohio Fire Code requirements for a fire access road. Correspondence had been received earlier that day from the County Prosecutor saying the road was not a fire access road.

Discussion ensued on the Ohio Fire Code and whether *Appendix D* would have been included in the District's adoption of the Ohio Fire Code. Chief McCann had sent the question to the state attorneys for their feedback. Mr. Cochran shared that he had been informed by legal counsel that *Appendix D* would not have fallen under the adoption of the Ohio Fire Code, unless it had specifically been adopted, and that language in the code supported that. After more discussion, the question was raised about waiting to hear confirmation from the State before a decision was made about the road having to meet the requirements of a fire access road as specified in *Appendix D*. Concern was raised about the possible ramifications of delaying the project any further, as the road had been approved by all other county entities, appeared to fall within the guidelines of the Ohio Fire Code and to meet all requirements for Knox County. Mr. Hackett shared that he was there in hopes of resolving the matter and felt the board had all the information they needed to make a decision that evening, as there had been ongoing delays and paving was scheduled for the following week. Further discussion ensued.

Mr. Cochran moved that the recommendation of the legal counsel be followed and any requirements of TRGC Holding, LLC meeting a fire access road be dropped. Mr. Dickerson seconded the motion. In the affirmative: Mr. Cochran and Mr. Dickerson. In the negative: Mr. Stewart.

### **REPORTS**

Chief McCann Report – (Attached)

Board will consider a contract with Fire RecoveryUSA, which identifies billable runs, similar to EMS soft billing. Chief McCann will do further research and report back to the board at the October meeting.

Discussion on Morrow County Sheriff's Office taking over 911 dispatching on Jan. 1, 2025. COJFD will consider reaching out to Morrow County Commissioners to propose 1.5 mills to provide EMS services. A decision would need to be made quickly as a Request for Proposal was put out with a deadline of Oct. 3. The board was given the contact information for Attorney Riepenhoff to ask any questions regarding this decision.

# **PUBLIC PARTICIPATION**

Liberty Township resident Jody Vance inquired about the proposed 5.925 Fire Levy on the fall ballot, and she was given printed information.

Discussion ensued on what led up to the decision for Liberty Township to contract with the Mount Vernon Fire Department (MVFD). The contract switched to MVFD in 2017 after Liberty Township voted to pass an additional levy for fire/ems services in November of 2016, not specific to MVFD. Mrs. Vance shared her concerns with MVFD serving Liberty, which included increased wait times for her portion of the township. Mr. Les Vance also expressed his concerns. When asked for direction, the Board and Chief McCann suggested that they, and any other concerned citizens, bring their concerns to the Liberty Township Board, as they would be the ones to enact change. Mrs. Vance requested the copy of the check that COJFD wrote to Liberty Township in early 2017 after the termination of the COJFD contract, which FO DeCosky would locate and send. Mr. and Mrs. Vance thanked the board for their time.

Chief McCann continued with his report.

On Chief McCann's suggestion, Mr. Stewart motioned to hire Part-Time EMT/FF John Baldinelli at \$17/hour, and Mr. Dickerson seconded. In the affirmative: Mr. Cochran, Mr. Dickerson and Mr. Stewart. In the negative: None.

Discussion on Chief McCann's letter and mailer regarding the levy. The Fire Levy Committee had voted to explain the annual cost as \$207 per \$100,000 of assessed value. Additionally, Chief McCann added the word "replacement" on the mailer.

Mr. Cochran moved to have the Fiscal Officer transfer \$16,945.29 out of Building (100-760-720-0000) to Repairs and Maintenance (1000-220-323-0000), and Mr. Stewart seconded the motion. In the affirmative: Mr. Cochran, Mr. Dickerson and Mr. Stewart. In the negative: None.

Mr. Dickerson moved to receive the State of Ohio Equipment Grant Fund in the amount of \$5,687.00 and spend it in accordance with grant specifications. Mr. Cochran seconded the motion. In the affirmative: Mr. Cochran, Mr. Dickerson and Mr. Stewart. In the negative: None.

Mr. Stewart moved to receive \$500 from the Ariel Foundation Grant program to be applied toward Adam Schlosser's Fire Officer 1 class at the Knox Technical Center, and Mr. Dickerson seconded the motion. In the affirmative: Mr. Cochran, Mr. Dickerson and Mr. Stewart. In the negative: None.
