# 3110 To receive apologies for absence Cllr Stephen Jones,

# <u>Open Forum</u>

Present: City Cllr M Thomas

Cllr Thomas explained that he had been approached by a resident about a branch from a tree on the recreation field that had fallen on to the property causing some damage. He was told that the parish council has the matter in hand and had been in contact with the resident. The council is waiting for a tree surgeon to remove the oak tree felled in a recent storm and if any other tree is presenting an immediate serious danger he will be asked to take any necessary action As the trees in this area of the recreation field are covered by a Tree Protection Order (TPO) an application has been made to Lancaster City Council to carry work on some trees in the interest of safety.

Cllr Thomas is still waiting to receive information about the ownership of a piece of land on Manor Road on which a tree was felled during a storm. It would seem that Lancaster City Council is checking deeds to confirm ownership. The Parish Council is willing to consider a suitable replacement for this tree.

Cllr Thomas left the meeting and Standing Orders were reinstated.

### 3113 Progress Reports

- The date for the felling of the fallen oak tree has been confirmed as Thursday 4 March.
- The Council has approved the clerk's suggested response to e-mails from a resident about alleged dangerous trees on the recreation field.
- Damaged signs on the foreshore -the Council's sign relating to overnight parking has been removed for repair and should be reinstated very soon: another damaged sign which the Council believes belongs to Lancashire County Council was reported to LCC, it is said to have been inspected and it is claimed that it is not LCC's responsibility -this is to be followed up.
- Local Members Grant application to Lancashire County Council; the Parish Council was not eligible to make the application therefore with the agreement of the Slyne with Hest Memorial Hall Committee it has been resubmitted in its name.
- Some incidents of damage at the recreation field and by the memorial hall were reported over the weekend of the 5<sup>th</sup>/6<sup>th</sup> March. This has been reported to the Police and they request that it is made known on social media that any incidents should be reported so that they can build up a picture of where problems occur. A damaged dog waste bin has been reported to Lancaster City Council

# 3114 Administration

Website; efforts continue to try to get the website up and running but not all obstacles have yet been overcome.

Jubilee Meeting held on Monday 14<sup>th</sup> March; 20 people attended and a range of ideas was discussed for the celebrations. The main events will be- on Saturday 4<sup>th</sup> June the Community Coffee Morning with a display of children's art work on the theme linked to the jubilee and a small exhibition of coronation and jubilee

memorabilia and with a Garden Party in the afternoon organised by the churches. On Sunday 5<sup>th</sup>, at noon

there will be a parade of crowns from the church hall to the memorial hall followed by the Big Jubilee Lunch at the

memorial hall and with various activities on the field (weather permitting) in the afternoon. Further details will be

discussed at the next jubilee meeting on Monday 28<sup>th</sup> March.

Consideration of a request from a resident for the use of Peacock Lane garden for a Jubilee party: This was agreed to with the proviso that area is left undamaged and clean and tidy after the party and all responsibility is with the party organisers.

Resolution: to appoint Mr M Richardson, clerk to Heversham Parish Council, as the independent internal auditor Unanimous agreement

Consideration of the feedback about the rent increases received from the Bowling Club and the Tennis Club; close scrutiny was given to the comments about the membership and financial status of the Clubs, the review of the leases and the explanations by the Clubs of the implications of the increased rents.

However it was decided that the Council would adhere to its previous decision to increase the rent in both cases to £500 per annum. The Clubs will be informed that if they wish to have an independent review they would be expected to pay 50% of the cost.

#### 3117 **Open Spaces**

Recreation Field; a meeting was held with Duncan Ross, contractor, to clarify some of the points relating to the construction of the Multi Use Games Area. During the meeting previous suggestions of widening the path at the side and back of the bowling green for access both during and after construction were mentioned. The Council has since looked at the quotation for the path work obtained at the time but funds are at present not available and the work on the paths is to be left in abeyance.

Some conditions on the approved planning application for the MUGA will need to be discharged before work can begin and work is in progress to collect together all the information needed for this.

A suggestion of the provision of medium sized goal posts on the newly drained grassed area for recreational football is to be followed up.

Consideration of the construction of a safety fence alongside the new raised path by the pond; the fence by the original boardwalk was removed when the new raised path was put in place There is a small drop on the pond side and some concern has been raised about anyone slipping into it. The installation of a wooden safety fence is to be looked into and a quotation sought for the work -left in abeyance until next meeting

Consideration of complaints received about the flooding of the area near to the Bowling Club and about the state of the path at the back of the club house; it had been reported that a person had fallen along the path leading from the bowling club's gate on to the bowling green during extremely wet weather. It has been stated that rainwater runs off the path from the middle gate of the recreation field on to the grassed area close to the Bowling Club causing flooding. Also a complaint had been received about the poor state of the path at the back of the Bowling Club pavilion.

These areas have been inspected and while some work may be carried out in the future, at present, funding is not available to carry out any remedial work. Checks will be kept on the area.

Further consideration of the improvement of the planters, there are 8 large tubs and 6 smaller ones. Cllr Cohen Kingsley has been investigating suitable summer perennials for them with possibly a red, white and blue colour scheme to mark the Jubilee. It was thought that further information was needed especially in relation to planting the tubs and the on-going care. Enquiries are to be made at local nurseries and plant centres about professional input.

Consideration of future inspection of the trees on parish council land -the Council's tree policy states that the trees will be inspected every three years. In the previous professional inspection report it is recommended that the trees are inspected in September 2022. Damage was done to some of the trees in recent storms, and in the interest of safety, arrangements will be made for a new inspection later in the year.
