The event is scheduled from 9:00 am to 2:00 pm on Saturday, August 19, 2023, at Turpentine Creek Wildlife Refuge, located at 239 Turpentine Creek Lane in beautiful Eureka Springs, Arkansas.

### **BOOTH SPACE AND COST**

1. Booths will be reserved and accepted on a first-come, first-serve basis by August 1, 2023. Vendors are asked to make payment before that date. Late payment submission could result in vendor being excluded from the event.
2. Operational hours for craft vendors will be 9:00 am to 2:00 pm on Saturday, August 19, 2023. Vendors can arrive one hour early (8:00 am) to set up their booth.
3. All craft vendors will be strategically placed on a designated area. Vendors must supply their own tents, tables, chairs and any other supplies needed for the sale of their products. Vendors must also provide sufficient staffing in booth(s).
4. There will be no cost for one 10x10 vendor space.
5. Electricity is **NOT** guaranteed, but on a first-come, first-served basis, **as available**. Vendors must supply their own extension cords, with final approval at the discretion of Turpentine Creek Mopar Classic staff.

### **Event management will not provide cash or change during the event.**

### **REGISTRATION, SET-UP & PARKING PROCEDURES**

Registration will begin upon load-in on Saturday, August 19, 2023, at 8:00 am.

Vendors will be required to visit the registration booth prior to setting up to discuss booth area.

Drop-off for loading and unloading will be allowed during setup/tear-down time only.
