### SPONSORSHIP AGREEMENT

Turpentine Creek Mopar Classic and \_\_\_\_\_ ("SPONSOR") hereby agree as follows:

1. **Sponsorship.** SPONSOR has asked to be named SPONSOR of the Turpentine Creek Mopar Classic ("EVENT") in exchange for \$\_\_\_\_\_ payment ("CONTRACT PRICE"). **Payment due in full within 10 days of agreement execution** or agreement may be cancelled.
2. **Event.** Subject to the terms and conditions of this Agreement, Turpentine Creek Mopar Classic offers the following sponsorship packages for the Turpentine Creek Mopar Classic Car Show (please check applicable package):
  - ☐ Presenting Sponsor - \$2,000
  - ☐ T-shirt Sponsor - \$1000
  - ☐ Main Show Awards Sponsor - \$1000

3. **Term.** This agreement shall begin on \_\_\_\_\_ and expire on June 20, 2026. Agreement is non-cancellable.
4. **No Assignment.** SPONSOR shall not, without prior written consent of Turpentine Creek Mopar Classic, assign or sublet any part of this Agreement.
5. **Hold Harmless.** SPONSOR agrees to hold harmless and indemnify Turpentine Creek Mopar Classic from all damage, costs and expense, of any nature whatsoever, arising from SPONSOR's participation in the EVENT.
6. **Entire Agreement.** This constitutes the entire agreement between the parties with respect to the subject matter hereof, all prior understandings being merged herein.
7. **Interpretation of Agreement.** In the event of disagreement regarding the meaning or interpretation of this Agreement, the interpretation of Turpentine Creek Mopar Classic shall govern.

### SECTION 2 – BOOTH SPACE

1. **Event.** Subject to the terms and conditions of this Agreement, Turpentine Creek Mopar Classic leases to EXHIBITOR the booth space described in Section 2 of this Agreement for the Turpentine Creek Mopar Classic car show to be held June 19-20, 2026. ("EVENT").

2. **Booth Space.** EXHIBITOR agrees to lease booth space(s) listed above at the price per booth indicated above. EXHIBITOR assumes all costs such as tables, chairs, additional lighting, electricity, carpeting, table linens, etc. The leased booth space shall be used exclusively by EXHIBITOR for the exhibition of the items described in Section 1 of this Agreement. EXHIBITOR shall not represent more than one business.
3. **Booth Selection and Availability.** Booth spaces are available on a first come, first served basis only. Turpentine Creek Mopar Classic does not guarantee specific booth spaces to any EXHIBITOR until booth space has been paid in full. If the desired booth is not available, Turpentine Creek Mopar Classic may substitute a different booth to be occupied by EXHIBITOR.
4. **No Assignment.** EXHIBITOR shall not, without prior written consent of Turpentine Creek Mopar Classic, assign or sublet any part of this Agreement or the leased booths.
5. **Failure to Comply.** If Turpentine Creek Mopar Classic determines that EXHIBITOR has failed to comply with any provision of this Agreement or the attached Rules of Use, Turpentine Creek Mopar Classic shall have the right to remove EXHIBITOR from the EVENT and, in which case, EXHIBITOR shall not be entitled to a refund of the Contract Price.
6. **Failure to Occupy Leased Booths.** EXHIBITOR agrees to occupy the leased booths for the full duration of the EVENT. If EXHIBITOR does not occupy the leased booths for the duration of the EVENT or leaves/begins to dismantle booth prior to the close of the event, Turpentine Creek Mopar Classic shall charge EXHIBITOR a fine of \$100.
7. **Notice of Cancellation.** If EXHIBITOR desires to cancel this Agreement, EXHIBITOR shall notify Turpentine Creek Mopar Classic of its desire to do so at least 60 days prior to the EVENT. If EXHIBITOR cancels this Agreement without providing 60 days advance notice, EXHIBITOR shall forfeit fifty percent of the Contract Price; provided that if notification of cancellation is made less than 30 days prior to the opening of the EVENT, EXHIBITOR shall forfeit the entire Contract Price.
8. **Set Up and Take Down.** All Exhibitors may set up from 7pm til 10pm (Friday Night Lights) or 9am til 2pm for the car show. EXHIBITOR must have his space set up before the EVENT is scheduled to begin. If EXHIBITOR has failed to set up by said time, EXHIBITOR may forfeit the leased booths and any payments and/or the entire Contracted Price and be fined \$100. Booths may be dismantled at the close of the respective show (10:00pm – Friday Night Lights; 2:00pm – Car Show). The EXHIBITOR is responsible for securing his goods and display items during set up and take down hours.
9. **Disruptive Behavior.** If Turpentine Creek Mopar Classic determines that the conduct of EXHIBITOR is disruptive to the EVENT or that EXHIBITOR is not acting in a courteous and professional manner, Turpentine Creek Mopar Classic may remove EXHIBITOR from the EVENT and, in which case, EXHIBITOR shall not receive a refund of the Contract Price.
10. **Waiver of Liability.** Turpentine Creek Mopar Classic will not be responsible or liable for any damage or loss incurred by EXHIBITOR as a result of fire, theft, wind, storm, explosion, or any other cause whatsoever. Turpentine Creek Mopar Classic is not responsible for damage from loss of occupancy or other loss to EXHIBITOR by destruction or damage to the exhibit area. EXHIBITOR releases Turpentine Creek Mopar Classic from any and all responsibility for theft or damage to equipment, booths or displays within the booths - by fire, rain, accident or any other cause whatsoever. EXHIBITOR assumes full and
