Big Tech, Self-Regulation and the Future of AI Laws

(Co-Author, Submitted to the High-level Advisory Body on AI, Office of the UN Secretary-General's Envoy on Technology, 2023;

As all technologies, Al is a double-edged sword, and can be used for either beneficence or harm. It is therefore important to develop social and economic regulations that promote the responsible use of AI. Amidst this evolving landscape, the dynamics of the public/private divide play a pivotal role in shaping the regulatory framework for AI technologies, adding layers of complexity to the governance of these powerful systems. As AI becomes increasingly integrated into the fabric of society, the distinction between the public and private realms becomes more blurred. This poses intricate challenges for regulators and industry stakeholders alike, prompting a critical examination of the interplay between public and private interests in the context of AI governance. To preempt government overpolicing, many AI firms have taken the initiative to establish self-regulatory measures. The question remains: how can these selfregulation initiatives within the global AI industry affect government-led regulatory policies, and what are its social, political, and economic repercussions? In this working paper, we analyze the main policy thrusts of the European Union, the United States, and China as the leading governmental bodies when it comes to AI regulation. Corollarily, we tabulate the priorities of leading AI companies in their bid towards self-regulation and assess them in the context of the principles of Responsible AI. Drawing insights from this dual analysis, we explore the potential impacts of industry-led priorities on government-led AI regulations. The complex interplay between public and private interests emerges as a critical factor influencing the formulation and implementation of AI policies. By navigating this complex legal terrain, we contribute to the ongoing discourse on shaping effective and responsible AI regulations that align with evolving societal expectations and ethical imperatives. We underscore the importance of a harmonized approach that melds both public and private law, and recognizes the complementary roles of both governmental oversight and industry-led initiatives in ensuring the responsible development and deployment of AI technologies.

Battling the Illegal Wildlife Trade through Regulatory Finance: The Southeast Asian Context

(Top 2 of 25, 2023 Amartya Sen Prize by Yale University's Global Justice Program and Global Financial Integrity; Presented at the Yale Global Justice Conference and Published at Journal ASAP (Academics Stand Against Poverty))

The illegal wildlife trade (IWT) is a US\$20 billion global industry, with significant environmental, economic, and sociopolitical harms. Fueled by a complex interplay of drivers and enabling factors, IWT poses concrete stumbling blocks for several UN Sustainable Development Goals. There is an urgent need for comprehensive reforms to address its multifaceted consequences around the world. In Southeast Asia, IWT is rampant as the region serves as a global hub for this black market. However, because of its characterization as an invisible threat, many aspects of IWT in the region remains understudied, particularly its relationship with illicit financial flows. In this paper, I look at the different economic and legal interventions to address IWT, focusing on regulatory finance. Adapting legal mechanisms from comparative jurisdictions, I propose three measures to be spearheaded by the Association of Southeast Asian Nations (ASEAN) Economic Community: first, to strengthen the implementation of existing financial crime instruments through specialized training and the utilization of emerging technology such as Al and blockchain; second, to append wildlife crimes as predicate offences to financial felonies, and; third, to utilize financial regulation instruments to fight poverty and support inclusive community development, encouraging communities to be proactive partners in long-term wildlife conservation.

Agricultural AI Adoption and Government-Subsidized Insurance

(Co-Author, published at Agriculture Web of Science Q1; Presented at the 20th Joint-Seminar of the European Association of Law and Economics and the Geneva Association, Krakow, Poland, June 2024)

Due to increased unpredictability and severity of weather patterns caused by climate change, traditional farming practices and risk management strategies are becoming increasingly inadequate. This situation poses significant risks to

global food security, necessitating innovative approaches to mitigate these impacts. In this paper, we explore the potential of Artificial Intelligence (AI) in mitigating climate-related agricultural risks and the pivotal role that public institutions play in encouraging farmers to adopt such technologies. However, the adoption of such AI technologies is hindered by high initial costs, limited knowledge, and perceived risks associated with new technological implementations. We explore a comprehensive framework that incentivizes the integration of AI in farming practices in government-subsidized insurance structures. In particular, we focus on the possibility of reduced premiums through government intervention. We argue that the provision of certain government interventions in the reduction of private insurance premiums in agriculture can effectively address these barriers by leveraging them as incentives for AI adoption. Not only these targeted subsidies, tax incentives, and regulatory support can enhance the attractiveness of AI investments in agriculture, but also, AI's potential to reduce the uncertainty and severity of climate-induced damages could lower the overall risk profile of insured farmers, thereby justifying lower premiums in the long run. We further discuss the implications of such policies on insurance markets, agricultural sustainability, and global food security.

How Much is Biodiversity Assessed in Climate Change Litigation?

(Co-Author, Presented at the 41st Conference of the European Association of Law & Economics, Turino, Italy, September 2024) In the context of the EU Biodiversity Strategy 2030, especially considering the post-COVID-19 era, biodiversity is acknowledged as a crucial asset for people, climate, and the planet, enhancing the resilience of our societies against future threats like "the impacts of climate change, forest fires, food insecurity, disease outbreaks - including by protecting wildlife and fighting illegal wildlife trade." The target of this paper is to investigate the extent to which biodiversity is factored into climate change litigation, at the same time exploring how courts can help achieve more biodiversity protection through climate change mitigation and adaptation. Utilizing a comprehensive review of literature and Natural Language Processing (NLP) for analyzing legal cases, we delve into the nuances of biodiversity in climate litigation, in particular how it is being considered in the valuation of environmental damage. By examining cases where plaintiffs seek remedies for climate-related damage across various jurisdictions, it becomes apparent that harm to lands, human lives, and moral injury are predominant themes in climate lawsuits. By identifying the presence of biodiversity considerations in climate litigation, our aim is to uncover the underlying patterns and implications of how biodiversity is currently addressed in these legal disputes. Considering our global analysis of climate change litigation documents, we undertake both qualitative and quantitative assessments through a combination of normative and positive analysis, including the innovative use of AI and NLP. Our initial findings suggest a notable gap in the explicit consideration of biodiversity within climate litigation, highlighting an area ripe for further exploration and potential integration into legal frameworks. This study contributes to the literature by demonstrating the current shortfall in adequately considering biodiversity in climate change litigation and suggests pathways for incorporating these critical environmental components into future legal actions. This paper can serve as a basis to improve the potential mechanisms through which such litigation can advance biodiversity protection as separate issue from climate change mitigation and adaptation.

Al Aristocracy? Inheritance & the Digital Dynasties of Tomorrow

(Supported by Yale Global Justice Program and Academics Stand Against Poverty

Presented at the Fifth Biennial Conference on Critical Trusts & Estates and Symposium of the Drexel Law Review, September 2024) Inheritance acts as a potent driver of inequality. Wealth and resources accumulate across generations, concentrating advantages in the hands of a privileged few. This skews access to opportunities, potentially limiting the ability of future generations to benefit from social, cultural and technological advancements. One of these advancements pertains to Artificial Intelligence (AI). While AI has been described as "the great equalizer," there remain many issues with AI and inequality, including access to quality education and the job market, disabilities, and even discriminatory practices based on existing social biases. Al has been shown to exacerbate inequality by favoring wealthy entities with resources for development, deployment and adaptation. Without proactive measures, AI risks deepening societal divides. This paper discuss how inheritance inequality exacerbates disparities in wealth distribution and perpetuates social stratification, with AI potentially amplifying this phenomenon. It provides evidence of nascent AI use cases in the field of inheritance and wealth administration. This includes document management and automation, scenario planning, tax optimization, fraud detection and risk management, among others. The paper discusses how unequal access to these kinds of technologies, especially with Software-as-a-Service (SaaS) bundled with estate planning and consultancy, can not only inadvertently encode biases and reinforce existing socioeconomic inequalities, but also further consolidate wealth and power within the hands of a select few across generations. The paper proposes to embrace inclusive AI design principles when adapting AI in the context of estate planning and inheritance management. Further, it

recommends exploring the use of AI in developing targeted interventions, such as inheritance taxation reforms and wealth redistribution mechanisms, to attenuate the concentration of inherited wealth, fostering greater socioeconomic parity. By fostering equitable AI in estate planning, inheritance management, and policies on private economic legacies, societies can strive towards a future where opportunities are not dictated by inherited privilege, but by individual merit and equitable access to resources..

Criminalising Climate Contention

(Co-Author, Presented at the International Conference on Planetary Crises & Human Rights, NCHR Oslo 2023;

Social mobilization and disruptive protest are indispensable ingredients in the battle against climate change. While a great deal of literature has focused on the role of legal modalities in reinforcing and complementing civic action aimed at mitigating climate change – including bringing environmental harms within the realm of criminal prohibitions – the 'dark side' of such legal mobilization has largely eluded scrutiny. In this paper, we explore the suppression of climate protest in and through criminal law. Drawing on an original database and select case studies from the Philippines and Germany spanning the years 2016 to 2023, we map (1) the types of climate protesters that have become targeted by criminal actions, (2) the activities being prosecuted, (3) the legal instruments invoked, (4) the arrest, prosecution, and conviction rates and (5) sanctions imposed (if any). Our empirical analysis illustrates that an increasing number of climate activists find themselves subjected to criminal investigations, prosecutions, and sanctions. Without going into the legalmerits of these cases, we discuss the potential impact of (over-)criminalizing climate activists. Ultimately, we argue for a more nuanced understanding of the double-edged nature of law as an ambivalent instrument in the struggle for sustainable futures.

Bridges, Not Walls: The Role of Migration and International Human Rights Law in Harnessing the Impending Demographic Tsunami

The substantial contribution of migrants to the global economy via remittances is particularly pronounced in developing countries, underscoring their economic significance. However, a considerable number of migrants embark on perilous journeys, resulting in over 46,000 migrant deaths since 2000. Human rights abuses further compound these challenges. This article delves into the intricate issues faced by millions of migrants, scrutinizing their economic roles and the absence of comprehensive legal protection. By highlighting the imminent demographic challenge, it explores the potential of migration in mitigating its impact. Stressing the imperative need for robust legal frameworks grounded in international human rights laws, the article advocates upholding migrants' fundamental rights as a pivotal strategy to avert the impending crisis. Employing a Critical Research framework, it analyzes international human rights laws and puts forth policy recommendations to mitigate the adverse effects of the impending demographic tsunami. The article concludes that the urgent necessity of embracing a human rights-centered approach to migration is evident, emphasizing its potential to alleviate the looming demographic challenges and propel inclusive economic development by recognizing migrants as valuable human capital.

Costs, Compliance, and Crime: Exploring Risk-Based Legal Strategies in Combating Transnational Environmental Harms in the ASEAN

(Awarded Best Presentation at Wageningen University's WASS PhD Day 2023; Presented at the International Law and Southeast Asia (ILSEA) Conference, the Hague, November 2024)

The Association of Southeast Asian Nations (ASEAN) faces an increasing number of transboundary environmental harms, causing billions of dollars in damages every year. To address these challenges, ASEAN and its Member States have installed a number of legal mechanisms both on a regional and domestic level. Many of these mechanisms focus primarily on civil damages and compensation. Unfortunately, these measures have been insufficient to deter further environmental harms. This article applies economic analysis of law to assess models of incentives and disincentives for human activities with deleterious environmental effects. It studies the risk equation and various implications of adopting a primarily civil legal mechanism to address transnational environmental harms, vis-à-vis a sturdy criminal justice framework. It asserts that to uphold the No Harm principle and achieve optimum compliance against transnational environmental harms, it is necessary to reinforce regional collaboration against green crimes, providing a strong legal framework and sufficient institutional support for its various components. This includes aligning domestic environmental legislation and strengthening enforcement, prosecution, and conviction rates across the ASEAN jurisdiction. The article explores a number of ways to do so: data-driven smart treaties promoting criminal sanctions for environmental harms; more interagency cooperation through mutual assistance pacts; joint prosecutions, transnational arrest warrants, and expedited extraditions, and; specialized environmental prosecution teams. It discusses their resulting benefits to the ASEAN coalition, as well as the potential institutional challenges facing the organization in implementing this initiative. In sum, ASEAN could provide an excellent test-case for strengthening the

international legal framework for environmental crimes. Through these initiatives, it could spearhead a balanced model of effective, efficient, and equitable policies against transnational environmental harms.

The Illegal Wildlife Trade as a Human Rights Issue

(Co-Author, Published at the Review of European, Comparative & International Environmental Law 2024; Presented at the IUCN (Academy of Environmental Law) AEL Conference, Joensuu, Finland 2023)

Cross-border illegal wildlife trade (IWT) is considered an urgent transnational criminal issue. This US\$20 billion black market poses a significant threat to global biodiversity, adversely affecting a number of critical industries, and undermines financial and criminal justice institutions. An anathema to the Sustainable Development Goals (SDGs), IWT disproportionately impacts developing, biodiversity-rich countries. Unfortunately, efforts to address this underground economy have been hampered by its traditional characterization as a primarily economic issue and a victimless crime. We argue against this misconception; instead, we posit that the harms of IWT tangibly impact not only socio-economic human rights, but also civil, political, environmental, and intergenerational rights. First, we discuss IWT's direct harms and negative externalities, both micro and macro. We then focus on the various international and regional legal mechanisms attempting to address the escalating IWT problem. Subsequently, we provide an introduction to the human rights lens as applied to IWT, emphasizing the various intersections of IWT and human rights violations, drawing examples from domestic case studies. Analysing international IWT agreements, particularly the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES), we highlight how multilateral legal frameworks fail to recognize the IWT-human rights intersections in how they address this challenge. We then show why it is advantageous to adopt a human rights perspective in designing and implementing laws, rules, and regulations in addressing the entire IWT supply chain. Ultimately, we conclude that for the successful implementation of counter-IWT legislation, it is necessary to adopt a radical mindset shift: a human rights perspective is not just desirable, but rather necessary, in the interpretation, application, and potential revision of policy interventions, for laws against IWT and other natural resource crimes to truly be effective and equitable.

The Role of AI in Fair Culture

(Co-Author, Fair Culture Journal, UNESCO Germany 2023)

We explore the application of fair trade principles to the fair culture movement through the use of artificial intelligence (AI). We highlight the potentials of AI-powered technologies in upholding the 2005 UNESCO Convention on the Protection and Promotion of the Diversity of Cultural Expressions. This encompasses creating a transparent and accountable record of fair culture products, ensuring the payment of proper compensation, local development, and adherence to certification processes. Other use cases include utilizing AI to incorporate fair culture recommendations into algorithmic systems used by global streaming platforms and e-commerce giants, all the while promoting non-discrimination, gender equity, and cultural diversity. We provide a number of existing AI technologies as non-exhaustive examples, including AI-powered blockchain, computer vision, natural language processing, and generative AI, and how they can be utilized to meet the goals of fair culture. However, while AI is a powerful tool for CCIs, we emphasize the need to regulate and protect the intellectual property of artists and indigenous communities, including sufficient attribution and compensation mechanisms. In line with the 2021 UNESCO Recommendation on the Ethics of Artificial Intelligence, we underscore the importance of considering ethical considerations and respecting privacy and cultural heritage in implementing AI technologies for fair culture.

The Road to a More Accessible Web: Bridging the Inequality Gap with AI

(Co-Author, Graduate Inequality Review, University of Oxford 2023)

The United Nations has hailed the Internet as a catalyst for the promotion of human rights and a necessary component for the attainment of the Sustainable Development Goals. However, the Digital Divide still remains, highlighting existing inequalities within the greater social sphere. A key factor that excludes certain populations from accessing the wealth of information available online is low web accessibility. Web accessibility refers to the ease of use of the Internet by persons with disabilities. This article proposes that this is an understudied dimension of inequality, both at the individual and societal level, potentially affecting 1.3 billion people in the world in varying degrees. It discusses how improving web accessibility can improve the lives not only of persons with disabilities but also the general social welfare as well. In line with this, it explores a number of artificial intelligence use cases which can be implemented to mitigate this pressing challenge. Finally, the article concludes that governments, industries, and academia should devote increased initiatives in how AI can be used towards improving web accessibility in order to bridge the Digital Divide and contribute to alleviating the global inequality gap.

Social Engineering & Cyber-Attacks: Cybersecurity, Terrorism, and Asymmetric Threats

In this volume published by CRC Press, the articles focused on the use of cyber-attacks both in the context of criminal activities & security-related threats. In particular, it discusses techniques in both psychology & computer engineering utilized to exploit system vulnerabilities, bypass security features of networks & inflict damage on the target systems, seeking to understand them better in order to prevent & mitigate their harmful impact.

Regulating The Regulators: Economic Assessment of the Regulatory Framework of PH Electricity Industry

(Published at the International Journal of Energy Economics and Policy, EconJournals 2023;

Presented at the 3rd International Conference on Energy and Environment Economics, August 2022)

This paper seeks to analyze the regulatory framework of energy economics in the Philippines. It looks at the historical legal policy background upon which these regulations stand, and seeks to understand how different factors contribute to the performance of the energy industry in the Philippines today, particularly in providing service to the communities all around the country. The first part provides a background of the current status of the economics of electricity in the Philippines, in contrast between the Philippines and other countries in comparatively the same circumstantial environments but with vastly different payment rates for electricity. The second part delves deeper and discusses its history, tracing the creation of landmark private industries, community cooperatives and regulatory bodies throughout the century, up to the present day and how the current energy regulatory framework operates. It seeks to isolate the extent of influence on this particular variable that regulatory frameworks exert. Lastly, the final part dissects the Philippine regulatory framework, applying standards and concepts for efficiency in regulation and identifying areas for improvement. It concludes by providing four key recommendations: adopting data-driven regulation; promoting a principle-based regulatory system; improving incentives against corruption and patronage politics, and; increasing consumer education. These steps can provide the backbone of reform that the Philippine regulatory system needs in order to push forward an efficient, human rights-responsive social energy framework for its citizens.

Greener E- Wallets: Blockchain Integration of Mangrove Assets as Carbon Tokens

(Best Environmental Pitch + Best Photoessay, Boston Congress of Public Health, HPHR Journal Hackathon 2022)

While there are many benefits to the use of blockchain technology, the challenge with cryptocurrencies and NFTs are that many of them are based on perceived value. This is why massive inflation and deflation can occur with the use of these tokens. The counterproposal is to use real-world value as basis for these electronic assets. One of them are carbon offset tokens. However, carbon tokens at present are very limited. There are only a few in existence, and many have not taken off the ground. It is also difficult to trade them, especially since there are no open platforms to do so. These assets, while growing, tend to stagnate compared to other tradable ones, including stocks and even crypto. Creating a handy wallet, stored on mobile, which allow for the trading of these carbon tokens can address this.

This project envisions three phases: *first*, the tokenization of mangroves in underserved coastal communities in Quezon, Philippines; *second*, the launch of an e-wallet which allows users easy access to these electronic assets for trade or for use, and; *third*, the gradual integration of mangrove tokens along with other carbon and environmental tokens into a single platform to encourage easier trading. This initiative is useful for environmental health by helping further climate justice, increase biodiversity to prevent the further rise of zoonotic diseases, and serve as protective barriers for traditional coastal communities, which are often underserved and marginalized.

Material Science v. SSI: Bioinspired Omniphobic Functional Surfaces against Surgical Site Infections

(Presented at the Boston Congress of Public Health Hackathon 2022; Published at HPHR Journal)

Surgical site infections (SSI) present a significant morbidity and mortality rate post-surgery, with effects more pronounced in developing countries than in developed ones. SSIs are not only personal burdens shouldered by individuals and their families; they also present a social cost to healthcare systems, with billions of dollars in economic losses every year due to unaddressed post-operative complications. There exists a number of initiatives and best practices to combat SSI, yet especially for developing countries, the statistics for infections remain relatively high, due to multiple factors. The authors propose the adaptation of newly-developed surface processing materials to be adapted for utilization in surgical centers and surrounding areas. This material, originally manufactured for application in the automotive industry, is both oleophobic and hydrophobic, which can be used to coat commonly-used objects in the surgery center, thereby reducing chances of microorganism retention, including infection-causing viruses, bacteria and fungi. Especially in underserved areas with limited resources, sanitation difficulties, and challenging hygiene practices, non-single use materials with these self-cleaning properties would be highly valuable for operating rooms and post-surgical care wards. Based on principles in exposure science, this new material can provide additional necessary environmental safeguards to prevent risks of SSI before, during and after surgery.

On the Choice of Sustainable Development Perspectives, as Applied in the South East Asian Region

(UPLB College of Economics and Management CEM Discussion Paper No. 21, December 2022)

The paper discusses sustainability from the perspective of the Association of Southeast Asian Nations (ASEAN). It traces the history of the regional body, as well as its efforts in integrating sustainability initiatives into its projects and programs. At the same time, it tackles the concepts of strong and weak sustainable development, highlighting their respective differences. Ultimately, it focuses on the question of biodiversity, and emphasizes why SSD is the best

approach in addressing the current challenges faced by Member-States. To conclude, the paper discusses the goal of ASEAN from its conception, including its premium as a top biodiverse region, and highlights why SSD is the only way forward for the region.

Framing Environmental Harms as a Transnational Criminal Issue: The ASEAN Perspective

(Presented at 24th International Conference of the Society for Human Ecology, Brazil, October 2021)

Modern communication and transportation technology has blurred national borders and boundaries, and this has both positive and negative implications for the Association of Southeast Asian Nations (ASEAN). While the increased mobility of people, goods and services fuel economic growth and cultural exchanges in a globalized society, it can also serve as an enabler for exponential damage on a much larger scale. Primarily, these negative effects pertain to the environment, as the laws of nature do not recognize politically-set boundaries. This wide potential for impact requires utmost cooperation between the ASEAN Member-States. However, of the eleven recognized transnational crimes under the ASEAN, only two of them are environmentally-related. This is in stark contrast to the necessity of preventing and addressing the harms of environmental damage through multi-perspective legal measures. This paper analyzes the current situation through the lens of law and economics. It proposes an ASEAN dual-pronged justice mechanism to address climate-related and other environmental harms from the perspective of prevailing transnational criminal justice norms, vis-a-vis the concept of efficiency and compensation. It posits that ASEAN, as an emerging economic power and a growing political commune, has both the mandate and the opportunity to pioneer this internationalized aspect of green litigation, merging both international environmental law and transnational criminal law in order to mitigate and effectively battle the deleterious impacts of environmental harm on a massive scale.

Enhancing the ASEAN Way: Integrating International Law into Local Initiatives in the ASEAN

(Published in "Advancing Rule of Law in the Global Context" Routledge - Taylor & Francis Group, August 2020; Presented at the International Conference of Law & Governance in the Global Context, Universitas Indonesia 2017)

The Association of Southeast Asian Nations (ASEAN) is a regional organization of countries aiming to promote amity & international cooperation between its member-states. It seeks to build a mutually-beneficial community supported by three pillars: political-security, economic & socio-cultural. The goal of ASEAN is primarily economic in nature: improving the mobility of goods & services within the region as well as facilitating trade with external partners. It was never meant to be a unitary political body similar to the United States or the European Union, hence the ASEAN Way: its emphasis on non-intervention in sovereign affairs & consensus-building. Because of this, ASEAN remains a mere potential to be a global force for change, particularly in areas of pressing regional concern like international environmental law & transnational criminal law, among others. This paper forwards recommendations in transforming ASEAN to more than just an Economic Community; rather, a leader of social change in the global setting. It focuses on cementing the ASEAN Way through more binding multilateral agreements, integrating various aspects of international law into meeting the United Nations' Sustainable Development Goals (SDGs). It does so through the perspective of citizen engagement, particularly youth empowerment, in order to rally regional political support for these initiatives. It concludes that for successful development in the region to take place, law & governance must be inclusive for all.

Economic Productivity, Infrastructure Development: Poverty and Economic Security

As contributing author to the Palgrave Encyclopaedia of Global Security Studies, the articles centered on economic productivity & infrastructure development, focusing on their roles in economic & global security. They also featured two international organizations based in Southeast Asia championing the cause of economic reform, both at the national & community level: the Center of Reform on Economics as well as the Urban Poor Consortium.

Tackling Terrorism in the Philippines: Legal Policies addressing this Non-Traditional Security Threat

(Published in Perspectives on Terrorism in the Philippine Context, UP Law Center, August 2019)

The 2017 Marawi crisis was a colossal eye-opener for the Philippines' security sector to re-examine its national response to the growing threat of domestic & transnational terrorism. This debacle of a siege, which lasted for five months, highlighted the unpreparedness of the government to promptly & efficiently address such attacks, & even moreso emphasized its continued inefficacy to prevent them at the outset. There are a number of factors at play in similar scenarios, one of the most important of which is the over-all comprehensive legal framework of the host state in tackling such terrorist threats. This introductory paper provides an overview of the Philippine laws applicable to terrorism, from the perspective of both domestic criminal law & transnational criminal justice. It discusses the legal concept of terrorism, its etymology, multiple definitions depending on jurisdiction, & various types as characterized by

both the legal regime under which it is addressed & the social sciences. It discusses national legal measures to address terrorism in the Philippines, which include the Revised Penal Code, the Human Security Act & the International Humanitarian Law Act, among others. It provides a brief critique of each, & then presents a comprehensive critical evaluation of the Philippine anti-terrorism legal framework. Its conclusion, based on both ideological & practical considerations, proposes general structural support & amendments to the legal regimes applicable in the field of counterterrorism & preventing violent extremism, in order to prevent such crises as the Marawi Siege from happening again.

Psychology, Law and the Filipino Terrorist

(Published in The Philippine Handbook on Transnational Organized Crime & Terrorism, National Police College, March 2019) As the sole Southeast Asian country to be included in the top 10 of the 2019 Global Terrorism Index, the Philippines faces the continuous threat of terrorist attacks. It is counted amoung the emerging regional hotspots for violent extremism & radicalization, & violence is poised to affect its most vulnerable of communities. This chapter on criminal psychology, law & terrorism seeks to guide our uniformed officers in understanding the factors which lead to the formation of a Filipino terrorist mindset. It provides an analysis of the personal, sociocultural & political backgrounds of violent extremists, as well as the various methods by which they are radicalized & encouraged to commit acts of terror. By doing so, it hopes to lend agents of the law a unique viewpoint into the mind of a would-be terrorist, & spearhead law enforcement & criminal justice initiatives aimed at the twin objectives of prevention of terrorist acts, & rehabilitation of offenders. The first part talks about psychology & the counterterrorism legal framework, situating the terrorist mindset within the context of Philippine law enforcement. The second part discusses the possibility of profiling terrorists based on psychological testing. Finally, the chapter concludes by adapting psychological tools & techniques as recommendations to strengthen strategies implemented at the level not only of the community but also at the level of creation of strategic policy. Taking into account the unique positions of various law enforcement agencies, this introductory chapter seeks to provide a deeper dimension into their understanding of how the terrorist mind works, in order to assist them in properly & effectively enforcing the law.

Technology, Disaster and Resilience: Can the ASEAN Policy Landscape Keep Up?

(Presented at 2nd International Symposium on ASEAN Studies, February 2018)

Due to the geography of Southeast Asia, the region is prone to many natural calamities, ranging from hydrometeorological catastrophes to geovolcanic cataclysms. This is why the Association of Southeast Asian Nations (ASEAN) as an economic community agrees that addressing its peoples' adaptability to natural disasters is a prime concern, particularly with the worsening conditions brought about by climate change. With the advent of everimproving information & communications technologies (ICTs), new electronic tools are constantly being developed in order to assist initiatives in disaster risk reduction & response management (DRRRM). This paper enumerates a number of best practices in how individuals, organizations & communities use e-tools in order to prepare & adapt to these calamities, & provide a closer look at the resiliency & creativity of the ASEAN spirit in utilizing technology to cope with the gravest of natural disasters. But more than that, the paper analyzes strategies at the level of national & international policy, evaluating the general legal framework through which effective e-initiatives can be adopted & implemented on a wider scale. It offers a comparative review of current DRRRM laws within the ASEAN region, & posits that not only do they fail to provide a solid policy foundation by which these ICT-based tools can be integrated & adopted into sustainable programmes, they also hinder them from doing so. Finally, the paper concludes by emphasizing the necessity to revisit & revise existing DRRRM policy frameworks, both at the domestic & regional level, in order to facilitate & maximize the utilization of ICTs in uplifting the ASEAN spirit of resilience, & preventing natural calamities from turning into full-pledged disasters.

Battling Transnational Terrorism in the ASEAN: The Relevance of IHL in ASEAN Community 2020

(Published in the Asia-Pacific Yearbook on International Humanitarian Law, International Committee of the Red Cross 2018)

Since the 1970s, the Association of Southeast Asian Nations (ASEAN) has been collectively committed to battling transnational crimes, which pertain to violations of law transcending national borders. Until 2001, the concept of terrorism has fallen under the ambit of this general classification. It was only after the events of 9/11 that it has been given separate treatment & more focus as a legitimate & growing security threat in the region. This paper utilizes country-focus analysis of the ASEAN member-states as well as examines key regional treaties, agreements & declarations regarding terrorism, evaluating the legal regime under which collective ASEAN policies & actions on anti-terrorism lie. It notes that while there is a move to address terrorism on a regional level, its emphasis on sovereignty &

the application of domestic law can hinder rather than help eradicate terrorism. The author forwards that ASEAN's success in addressing regional security concerns as a multilateral cooperative economic community in 2020 would depend heavily on its ability to adopt & abide by standards set by International Humanitarian Law (IHL) when applicable, both on its perspective on terrorism & how it proffers counterterrorism measures for individual member-states & as a collective.

Defeating Inverted Pentagrams: Criminal Liabilities of the Chief of State & His Minions in Errant War on Drugs

(Originally Published in the ALSA Law Review- Asian Law Students' Association, August 2017; Republished in the ELSA Law Review- European Law Students' Association, 2018)

In light of Philippine President Rodrigo Duterte's War on Drugs, this article discusses several key issues which relate to its implementation. It discusses Operation Tokhang & notes that the extrajudicial killings accompanying it show the failure of the Executive to uphold Republic Act No. 9165, or the Comprehensive Dangerous Drugs Act of 2002. It analyzes legislation & case law which could give rise to criminal liability of the Commander-in-Chief & errant law enforcers under domestic & international criminal law, despite the cloak of Presidential Immunity & the ability of the Chief Executive to grant absolute pardon. It also discusses various legal remedies for citizens directly & indirectly affected by the Duterte Administration's War on Drugs, & posits that the Courts retain the power to prevent these abuses from further happening, as well as penalize those who have exceeded the scope of their authority & exercised abuse of office.

The Criminal e-Cosystem: Navigating Transnational Cybercrimes in the Age of ASEAN Economic Integration

(Presented at the 22nd International Conference of the Society for Human Ecology, November 2017)

The rapid pace of technological development is breaking down barriers among nations, giving new meaning to the term 'global community.' Whereas states used to be the primary actors in the international scene, today the human individual takes the stage, thanks in huge part to cyberspace as a new, borderless ecosystem to navigate. But with the advent of new frontiers also come new challenges, & one of the most pressing concerns of the international cybercommunity are transnational cybercrimes. This paper discusses the concept of cybercrimes, their transnational nature & how they can affect the environment of communities in transition. In particular, it focuses on the Association of Southeast Nations (ASEAN) as an emerging global economic power, & considers the impact of transnational cybercrimes on the goal of ASEAN 2025 if left unchecked. Policy Analysis fleshes out the strategies employed under both domestic & international criminal law to prevent cybercrimes, as well as assess their over-all efficacy. The paper concludes that the booming population of Internet users in the ASEAN, as well as the growing dependence of all industries on the cyberworld, necessitates prompt prioritization of cybersecurity as a key policy & social issue needed to be addressed both at the national & international level, in order to properly protect the environment & prevent looming environmental damage to the region.

Transforming Momentum into Propulsion: Harnessing the Demographic Tsunami

(Award for Brilliance, Eisaku Sato Competition, United Nations University, November 2017)

The essay discusses the phenomenon termed 'demographic tsunami' & its possible repercussions in the global socioeconomic & political arena in the near future. It talks about the UN Sustainable Development Goals (UN SDGs) & the challenges that meeting them faces, in light of this continuous worldwide demographic imbalance. It identifies three key divides which further complicate the problem: the generational divide, the gender divide & the economic divide. It posits that in order to address this pressing concern, it is necessary to bridge these gaps. The author offers a series of propositions from the perspective of international law & best practices in governance & the development sector which are geared towards youth empowerment, structural reforms in education & sustainable, circular labor migration & reintegration. It also emphasizes the empowerment of women & the positive role of ICTs in assisting inclusive global development. The author also discusses the issue of refugees, which comprise 65 million of the total 244 million international migrants as of Q4 2015. He forwards that instead of viewing them as state burdens, they should be considered as additional factors to boost diversity, productivity & economic gains. In conclusion, the essay advances that instead of designating the phenomenon as a 'demographic tsunami', it should be considered instead as 'demographic propulsion,' signifying a collective, global drive to move forward for inclusive, sustainable development.

21st Century ICTs: The Way Forward Information & Communication Technology and the Youth

This exploratory paper is a cooperative effort between young professionals, academicians & development specialists from various sectors worldwide. The research was designed & supported by ADB Youth for Asia and World Economic Forum's Young Global Shapers. As a narrative, it lays the background of traditional uses of information & communications technologies (ICTs). It then aims to identify new developments in the field & how these disruptions can impact governance & economics for welfare states in the coming years. In particular, case studies focused on artificial intelligence, augmented reality, big data, financial technologies, the internet of things, & smartphone applications, as applied in various sectors of development. The paper is written from the perspective of the United Nations' Sustainable Development Goals 2030, & explores the key role of the youth in achieving these goals with ICT tools & platforms. It recommends key investment & capitalization actions by the Bank in order to maximize the potentials for economic & social development of welfare states. This paper is intended to be a preliminary step towards the creation of a complete knowledge & training package to be disseminated to target audiences including the Asian youth, policy makers & the private sector.

Forging On, Volting In: Japan-ASEAN Mechanisms in Battling Crimes beyond Borders

(Presented during the International Studies Conference, August 2017)

Globalization has brought about the huge potential for global economic growth & an enriched international cultural experience. In addition, rapid developments in technology have driven innovation in the fields of transportation & communication across the world, further breaking down barriers towards establishing a truly global community. But with these new frontiers come new challenges, both legal & practical. One of them are crimes beyond borders, also known as transnational crimes. The Association of Southeast Nations (ASEAN), as an important economic & political alliance, is instrumental in eradicating the problem of transnational crimes. In fact, efforts have been made by the regional organization since the 1970s to address this concern. However, ASEAN alone has seen a sharp rise in transnational crimes in recent times, leading to a crisis of international proportions which needs to be immediately addressed. In order to properly do so, it may require external assistance. Japan has always been a key ally in various concerns of ASEAN, & indeed shares a rich history with the region's members in various political, economic & security concerns. One particularly crucial area of cooperation pertains to transnational criminal law mechanisms. With the forecasted rise of transnational crimes in the Asia-Pacific Region in 2017 & beyond, this paper analyzes the important role of Japan in addressing transnational crimes in ASEAN & seeks to identify the potential impact of a stronger Japan-ASEAN partnership, taking into account various national & regional security considerations. It posits that this partnership could have a potentially transformative role in battling transnational crimes in the region, & this in turn can greatly affect how transnational crimes are addressed as an international peace & security concern by the global community in the foreseeable future.

When Order has Fallen: Philippine Criminal Justice in the Aftermath of Natural Calamities

(Presented at the 6th International Law, Regulations & Public Policy Conference Singapore; Published as Proceedings 2017)

This paper analyzes crime & justice in the aftermath of natural calamities in the Philippines. In particular, it zooms in on Tacloban City, one of the urban areas directly hit by Typhoon Haiyan, & notes how the national government failed to afford protection & decent standards of living for victims of the disaster, in contravention of its obligations both under the Constitution & international human rights laws. Relevant provisions under the Revised Penal Code are analyzed, as well as the Philippine Disaster Risk Reduction & Management Act of 2010 (Republic Act 10121).

The author forwards that the implementation of public order through criminal justice should have been prioritized for humanitarian aid to be properly implemented & recommends a revisit of the underlying principles of RA 10121. He proposes general policy modifications at the level of both local & national government in relation to disaster risk reduction, response & management, particularly promoting the idea of public order & welfare as twin complementary concepts in effective disaster relief.

Setting Examples: The Potentially Transformative Role of the Philippines in Battling Transnational Crimes in the ASEAN

(Presented at the National College of Public Administration & Governance International Conference, August 2017)

Through technology & development, increasingly easier means of transportation & communication have fuelled global economic growth & more enriched sociocultural interactions. In the political sphere, however, this trend translates into increased global & regional security concerns, particularly for countries with porous & contiguous borders. Foremost among them are terrorism & transnational crimes. As early as the 1970s, the Association of Southeast Asian Nations

(ASEAN) has forwarded steps in order to address this, with several key declarations & agreements promising regional cooperation to combat cross-border criminal activities. Despite these efforts, ASEAN has seen a sharp rise in transnational crimes more than 4 decades later, leading to a crisis of international proportions which needs to be immediately addressed. With the Philippines taking the lead role in ASEAN in 2017, this paper seeks to identify the potential impact of its leadership in this initiative, taking into account the aggressive shift in the country's criminal justice policies. It posits that the Philippines' internal policies could have a potentially transformative role in battling transnational crimes in the region in line with ASEAN 2030, & this in turn can greatly affect how transnational crimes are addressed in the international community in the foreseeable future.

Empowering Survivors in the Asian Climate Battleground: Proposing a Criminal Justice Model for Crises after Calamities

(Published in the Asian Journal of Legal Studies, August 2017)

Criminal justice mechanisms are often overlooked in the crafting of laws, rules & policies related to disaster risk reduction, response & management. This leads to the detriment of citizens in communities ravaged by calamities, for they are doubly victimized, first by the consequences of the natural phenomena, & second by the ineffectuality of the criminal justice system in their locale in the chaos following the storm. This paper examines the effects of such oversight in Asia. In particular, it analyzes legislation & jurisprudence related to the intersection of disaster law & criminal law, & how it has failed in the aftermath of the strongest storm to ever make landfall in history. Applicable not only to the Philippines but also to greater Asia, it recommends best practices & key policies for stronger criminal justice mechanisms to take effect in the aftermath of natural calamities, in order to prevent abuses on the accused, support community rehabilitation & ultimately uphold human rights.

Countering Cyberlibel: A Practitioner's Perspective

(Presented during the 45th Veterinary Practitioners' Association of the Philippines Conference 2017)

The Philippines is considered the social media capital of the world: many aspects of modern Filipino life, be it social, economic & political, are expressed online. In light of this, the government has made efforts to regulate behavior in cyberspace, particularly those which are criminal in nature, one of which is online defamation. Under Philippine law, defamation is the public & malicious imputation of a crime, vice or defect. The law does not distinguish whether such is real or imaginary; as long as it tends to cause the dishonor, discredit, or contempt of a natural or juridical person, or to blacken the memory of one who is dead, then it can be considered libelous. A number of recent incidents in social media show that practitioners of veterinary medicine are particularly prone to online defamation, & this fact has enormous repercussions on their professional stature in the industry, their livelihood, & their name in the community. This communication paper uses a social science-based case-study approach to highlight instances of libel & bullying through social media, particularly directed at practicing veterinarians by irate owners who perceived themselves harmed by the former's professional actions. It details both the human & environmental factors common to both of them, & places them side-by-side with the elements of crimes under which these acts can be classified under the Revised Penal Code of 1930 & the Cybercrime Prevention Act of 2012. It enumerates both practical & legal steps which veterinarians can undertake to prevent further damage, as well as to seek redress for harm already done. It concludes that the practice of the veterinary profession must be constantly imbued with care & reasonable foresight, & requires working closely with both the legal profession & the public in order for such harms to be prevented.

All Hands on Deck: The Role of Law & Governance in Accelerating Global Climate Action

(Invited to Climate Law & Governance Day 2017 in Bonn, Germany-- COP23, November 2017 Published in the University of Asia and the Pacific Law Journal 2021)

Climate change is an undisputable fact, a global problem of epic proportions. Because of this, it also requires a similarly-scaled solution: everyone working hand-in-hand in order to battle it. This essay discusses humanity's role as both cause & solution of climate change. It tackles law & governance as a social mechanism by which human behaviour can be regulated, as well as the different levels under which it operates. It provides the Association of Southeast Asian Nations (ASEAN) & the Philippines as examples of the interplay between national & international law in the context of climate action. Finally, it suggests potential sociopolitical strategies based on international relations, domestic legal affairs & on-the-ground implementation in order to effectively combat climate change. It concludes with the need for collective, strategic action on all levels of policy & implementation in order for climate action to truly have an impact.

How Stories can Change the World: Reflections on Human Rights, Peace and Social Media

(Presented at the Plenary Session, 4th International Conference on Human Rights, Peace & Conflict, Bangkok 2016)

According to the United Nations, access to the Internet is a basic human right. However, the increasing use of social media as a primary news source has led to the simplification of stances on key social issues involving peace & human rights into mere dichotomies. This type of direct democracy has often fuelled incompletely-informed actions rooted in mob mentality. The author aims to explore the dynamics of human interaction & political discussion in social media, tackling the concepts of desensitization & learned helplessness. He posits that these factors have helped fuel the rise of modern Messianic figures around the world, promising change oftentimes through the politics of fear & misplaced anger. He also suggests ways by which information campaigns can be designed as true-to-life stories in order to reach out to people of opposing & maleducated political mindsets, as well as how individuals can help polarize the increasingly violent socio-political atmosphere that social media has engendered. The author recommends that more than mere facts & figures, working on the prevailing user engagement framework of both trending & truth-telling through the Storytelling concept, means & methods can help harness the enormous potential of social media to promote peace & human rights across cyberspace, translating into concrete actions in the external world.

Human Rights in the Context of ASEAN Transnational Criminal Justice

(Presented during the Human Rights Symposium for the Youth, Universitas Indonesia 2016)

The Association of Southeast Asian Nations (ASEAN) has time & again expressed its deep commitment to upholding human rights. In line with this, it has established the ASEAN Intergovernmental Commission on Human Rights, which came out with the ASEAN Human Rights Declaration (AHRD) in 2012. The AHRD seeks to uphold the Universal Declaration of Human Rights (UDHR) as well as other essential rights not embodied therein, & envelope them in pivotal areas of the ASEAN Economic Integration, one of which relates to transnational criminal justice.

As early as the 1970s, ASEAN countries have recognized the need for concerted efforts to address the problem of transnational crimes. Its collective commitment against transnational crime is embodied in several key agreements & declarations, reaffirming their joint & cooperative commitment to battling transnational crimes. This paper analyzes current ASEAN declarations, national & regional policies, & intergovernmental state actions regarding transnational criminal law, & seeks to determine whether the ASEAN transnational criminal justice framework provides enough safeguards & protection for human rights across its ten-country jurisdiction. It identifies potential problem areas & suggests recommendations as to how the implementation of transnational criminal justice in the ASEAN can complement & ultimately uphold human rights.
