

Aquamassage Ltd Privacy Policy

Aquamassage Ltd [the “company”] is committed to maintaining robust privacy protections for its users. Our privacy Policy [“Privacy Policy”] is designed to help you understand how we collect, use and safeguard the information you provide to us and to assist you in making informed decisions when using our service.

For purposes of this Agreement, “site “refers to the Company’s website, which can be accessed at www.aquamassagetherapycushion.co.uk and www.stonesaquamassage.com

“Service” refers to the Company’s services accessed via the site, in which users can, Purchase Aquamassage Therapy Cushions, Training Courses, Equipment, and Treatments.

The terms “we”, “us”, and “our “refer to the Company.

“You “refers to you, as a user of our Site or our Service.

By accessing our Site or our Service, you accept our Privacy Policy and Terms of Use {found here: www.aquamassagetherapycushion.co.uk}, and you consent to our collection, storage, use and disclosure of your Personal Information as described in this Privacy Policy.

1. INFORMATION WE COLLECT

We collect “Non-Personal Information” and “Personal Information”. Non-Personal Information includes information that cannot be used to personally identify you, such as anonymous usage data, general demographic information we may collect, referring/exit pages and URLs, platform types, preferences you submit and preferences that are generated based on the data you submit and number of clicks. Personal Information includes your email {Name, Address, Contact number}, which you submit to us through the registration process at the Site.

2. INFORMATION COLLECTED VIA TECHNOLOGY

To activate the Service you do not need to submit any Personal Information other than your email address. To use the Service there after you do need to submit further Personal Information [which may include, Name, Address, Contact details]. However, in an effort to improve the quality of the Service, we track information provided to us by your browser or by our software application when you view or use the Service, such as the website you came from [known as the “referring URL”], the type of browser you use, the device from which you connected to the Service, the time and date of access, and other information that does not personally identify you. We track this information using cookies, or small text files, which include any anonymous unique identifier.

Cookies are sent to a users browser from our Servers and are stored on the users comport hard drive. Sending a cookie to a users browser enables us to collect Non-Personal information about that user and keep a record of the users preferences when utilizing our services, both on an individual and aggregate basis.

3. HOW WE USE AND SHARE INFORMATION

Personal Information:

Except as otherwise stated in this Privacy Policy, we do not sell, trade, rent or otherwise share for marketing purposes your Personal Information with third parties without your consent. We do share Personal Information with vendors who are performing services for the Company, such as the servers for our email communications who are provided access to users email address for purposes of sending emails to us. Those vendors use your Personal information only at our direction and in accordance with our Privacy Policy.

In general, the Personal Information you provide to us is used to help us communicate with you. For example, we use Personal Information to contact users in response to questions, solicit feedback from users, provide technical support, and inform users about promotional offers.

Non-Personal Information

In general, we use Non-Personal Information to help us improve the Service and customize the user experience .If our Information practices change at any time in the future; we will post the policy changes to the Site so that you may opt out of the new Information Practices. We suggest that you check the Site periodically if you are concerned about how your information is used.

4. HOW WE PROTECT INFORMATION

We implement security measures designed to protect your information from unauthorized access by using certain technological security measures including encryption, firewalls and secure socket layer technology. However, these measures do not guarantee that your information will not be accessed, disclosed, altered or destroyed by breach of such firewalls and secure server software. By using our Service, you acknowledge that you understand and agree to assume this risk.

5. YOUR RIGHTS REGARDING THE USE OF YOUR PERSONAL INFORMATION

You have the right at any time to prevent us from contacting you for marketing purposes. When we send a promotional communication to a user, the user can opt out of further promotional communications by following the unsubscribe instructions provided in each promotional email.

You can also indicate that you do not wish to receive marketing communications from us by typing in opt out in the heading section on the email.

6. CHANGES TO OUR PRIVACY POLICY

The company reserves the right to change its policy and our Terms of Service at any time. We will notify you of significant changes to our Privacy Policy by sending a notice to the primary email address specified, or by placing a prominent notice on our Sites. Significant changes will go into effect 30 days following such notification. Non-material changes or clarifications will take effect immediately. You should periodically check the Site and this privacy page for updates.
