1. Parties

This Deposit Agreement (“Agreement”) is entered into as of _____, by and between Nebula Ranch Pomskies (“Breeder”) and _____ (“Buyer”).

2. Deposit Amount

Buyer agrees to pay a deposit in the amount of Four Hundred Dollars (\$400.00) (“Deposit”) to reserve Buyer’s place in line for selection of a Pomsky puppy from Breeder.

3. Purpose of Deposit

The Deposit secures Buyer’s position in the puppy selection order and reflects Buyer’s intent to purchase a puppy from Breeder. The Deposit does not guarantee availability of a specific puppy, sex, color, markings, eye color, coat type, or adult size.

4. Non-Refundable Deposit

The Deposit is NON-REFUNDABLE under all circumstances, except where prohibited by law. Buyer acknowledges that changes in personal circumstances, housing, finances, family situation, or timing do not constitute grounds for a refund.

5. Transferability

The Deposit IS transferable. If Buyer elects not to move forward with a puppy from the originally selected litter, Buyer may apply the Deposit one (1) time toward another available puppy or a future litter from Breeder. The Deposit may not be transferred to another buyer and may not be redeemed for cash.

6. Breeder Unavailability

If Breeder is unable to provide a puppy reasonably matching Buyer’s stated preferences within a reasonable timeframe, Buyer may elect to either (a) transfer the Deposit to a future litter, or (b) receive a refund of the Deposit.

7. Application of Deposit

The Deposit shall be applied toward the final purchase price of the puppy at the time the Puppy/Dog Purchase Agreement & Guarantee is executed. The remaining balance shall be due prior to pickup or transfer of ownership.

8. Payment Method

All payments shall be made in United States Dollars through Good Dog. Breeder does not accept any other forms of payment.



9. **No Chargebacks or Payment Disputes**

Buyer agrees not to initiate a chargeback, payment dispute, or reversal with any financial institution or payment platform. Buyer must provide Breeder written notice and allow a reasonable opportunity to resolve the issue in good faith prior to initiating any dispute.

10. **Relationship to Purchase Contract**

This Agreement is incorporated into and made part of the Puppy/Dog Purchase Agreement & Guarantee. In the event of any conflict between this Agreement and the Purchase Agreement regarding deposit terms, this Deposit Agreement shall control.

11. **Governing Law**

This Agreement shall be governed by and construed in accordance with the laws of the State of Washington.
