Police and Emergency Response December 11, 2018

These three courses are curtailed to your agency's needs. If you need the **40-hr OSHA Compliant Clan Lab class** we have a course scheduled in Slidell LA. If you are certified and need your **annual refresher** course we have dates available as well. And for the first time MERIT is offering a **field level awareness training** covering Fentanyl and heroin operations, BHO and marihuana labs and of course meth labs. Our awareness training is far more than a general understanding of these illicit labs. Students will leave these courses with a near expert understanding of the items used, dangers specific to these clan labs and a new sense of safety! The 40-hr course covers the following:

Response Plan and Techniques

Identify Illicit Drug Lab Operation

Investigations and Evidence Collection

Chemical Handling and Drug Testing

PPE and Necessary DECON Techniques

Emergency Scenarios and Action



In this course students, will follow a curriculum compliant to the OSHA HAZWOPER program including medical monitoring, personal protection equipment choice, air-monitoring and many other safety mandates. Then the core program begins with identifying the illicit operation taking place at a site. Many agencies are aware there are hazards found in clandestine meth and fentanyl labs, but what about 'Whipping' operations and Indoor Marihuana Grows? These pose very serious health concerns equal and sometimes more deadly than other clandestine labs which put less trained responders in mortal danger!

Once the student has mastered the identification of these operations, they are trained to identify the equipment necessary to process the site safely and offer DECON of personnel to reduce the risk of cross contamination and or death. At this point the practical training begins allowing the student to utilize the equipment learned about in lecture.

Students will participate in identifying mock clandestine operations including methamphetamine, fentanyl, heroin and marihuana grows and finally begin the process of collecting evidence and field testing. Quick, essential and pertinent testing procedures will be mastered by the student while donning protective equipment.

The final test involves an actual clandestine lab response. Each student is trained to process the materials in these operations and supervise the operation if necessary. Officers will be trained to recognize the signs of exposure and take the necessary steps to safeguard their personnel. All students will be field ready at the end of the training.

Clan Lab Response course is being offered. The course includes manufacture and trafficking of Heroin, Fentanyl, Methamphetamine and indoor grown marihuana, Students will be trained to process and supervise these illicit drug operations. This course is taught by forensic scientists, police and experienced clandestine lab responders. This is an OSHA compliant class.

8-hour Annual Re-Certification Class which will be provided to any response officer who previously completed a 40-hour Basic Clan Lab HAZWOPER Training, for meth labs through MERIT or another company. This training will provide updated drug lab information and practical training which will meet and exceed annual recertification curriculum. Every officer receives a new certification and updated manual following training. Officers may choose lecture recert, live mock drill or can choose to attend both days at no additional tuition.

Clan Lab Awareness training! This is not like other awareness training. Students will learn intricate details of clandestine labs and leave with a near expert understanding of clandestine labs!
