MFPI BOARD RESOLUTION 3 SERIES OF 2022

“INCREASING THE ADMISSION FEES AND ANNUAL DUES FOR THE FISCAL YEAR OF JANUARY 1 TO DECEMBER 31 2023”

WHEREAS, *Article II Section I of the amended Articles of Incorporation of the Mountaineering Federation of the Philippines Incorporated (MFPI) that the corporate powers of the federation shall be exercised, its business conducted and its property controlled by the Board of Trustees.*

WHEREAS, *Article IV Section IV of the amended Articles of Incorporation of the Mountaineering Federation of the Philippines Incorporated (MFPI) that the qualifications and requirements for membership shall be determined by the Board of Directors.*

WHEREAS, *ARTICLE V of the amended Articles of Incorporation of the Mountaineering Federation of the Philippines Incorporated (MFPI) that if any member in default in payment of dues shall be suspended from all privileges of membership and if, after notice the default be not cured within the period of ninety (90) days, the membership of the member shall automatically cease and terminate.*

WHEREAS, *ARTICLE VI Section I of the amended Articles of Incorporation of the Mountaineering Federation of the Philippines Incorporated (MFPI) that the funds of the federation shall be derived from admission fees, annual dues and special assessment of members, gifts, donations and benefits.*

WHEREAS, *ARTICLE VI Section II of the amended Articles of Incorporation of the Mountaineering Federation of the Philippines Incorporated (MFPI) that every member of the federation shall in addition of the membership fee, pay dues and/or assessments that may be imposed by the federation from time to time.*

WHEREAS, *record shows that since the year of 2000 up to this fiscal year of 2022 the Annual Dues is still fixated to P200/year for each Regular Member and P2,000/year for a Club Member in the said fees the printing cost of the federation id is included.*

WHEREAS, *that to effectively administer the duties and responsibilities of the officials this organization the federation coffers must be replenished in order to subsidize projects and/or programs that is oriented to the overall general welfare of the membership.*

WHEREAS, *that on the start of the fiscal year or the 1st Day of January up to the 31st Day of December of 2023 the Annual Dues is now raised from P200 per Regular Member to P500 per Regular Member and from P2000 per Club Member it is raised to P3000 per Club Member excluded from the fee is the printing of the federation ID which must be fixed at P200.*

WHEREAS, *to properly finance the events, programs and projects of the federation and to effectively collect the annual dues the last day of payment of the membership fees is set on the May 31st 2023.*

NOW, THEREFORE, *on the joint motion unanimously **APPROVED.***

RESOLVED, *that effective on January 1st up to December 31st of year 2023 the Annual Dues of the federation is now P500 per Regular Member and P3000 per Club Member excluded from the fee is the printing of the federation ID which is now fixed at P200 per MFPI ID and to effectively collect the said fees the deadline of annual dues is now set on the 31st day of May, 2023.*

RESOLVED FURTHER, *that this resolution forwarded to Vice President for Mindanao Restie Torres and Public Relations Officer Ken Vibar and all concerned, for their information and appropriate action.*
