On 2023-06-14 the Water Quality Control Division received a request to modify this certification by: adding 5 acres to the permitted area.

The Water Quality Control Division (the Division) has reviewed the application submitted for the **Westerly Community, Select Lots** facility and determined that it qualifies for coverage under the CDPS General Permit for Stormwater Discharges Associated with Construction Activities (the permit). Enclosed please find a copy of the permit certification, which was issued under the Colorado Water Quality Control Act.

FEE INFORMATION: 8.35 acres

A modification fee of \$88 (25% of the annual fee) will be assessed for all modification applications.

It is the responsibility of the permittee to submit a termination application when the permit is no longer needed. Fees are assessed and invoiced for every permit that is active July 1 of the fiscal year. Permits for which termination applications are received by June 30 of the current fiscal year will not be invoiced for the new fiscal year.
