One male was medium skinned with a Gotee, black T shirt, 20 to 25 years old and 5feet 6 inches tall. The other one was 5feet 10 inches tall thin build with no facial hair wearing black stocking cap, blue and white striped shirt and counting money. | |
| Half hour later a gray van parked at 23984 Banbury and a white male got out and approached myself, Damon Leggett and Dave Pasley and asked "were you the ones that called me" | |
| We said no. He walked back to his van then the same 2 males got into the van with him and they drove away. Later the office called and told us that someone got shot and we recognized the van and the white male that was shot as the male that asked us if we were the ones that called him. The 2 males that were suspicious are not familiar in the Banbury Complex and I never saw them before. | |



