- The loaned art shall remain in the possession of The Polish Center of Wisconsin for the entire time specified in this agreement but may be withdrawn from exhibition by The Polish Center of Wisconsin at any time.
- Except in case of emergency to preserve art, the art shall not be cleaned, restored or otherwise altered without the written consent of the Lender. Should any of these actions be required, the Polish Center of Wisconsin shall notify the Lender in a timely manner.
- Any sale of loaned art during the period of this agreement shall be strictly between the Lender and the Buyer. The Polish Center of Wisconsin shall not be involved in the sales transaction.
- Unless otherwise agreed upon, the Lender shall be responsible for transporting the art to and from The Polish Center of Wisconsin.
- The Lender shall be responsible for appropriately framing and wiring all art, as required (gallery-ready).
- Although every effort shall be made to honor the wishes of the Lender, The Polish Center of Wisconsin reserves the right to make the final decisions on appropriateness of the art regarding subject matter size, framing, exhibition location, etc.
- Either party may terminate this agreement by giving the other party a 30 calendar-day written notice.

I certify that the above information is accurate. I further certify that I am the owner or agent of the owner authorized to enter into this agreement and that the art is not subject to any lien, encumbrance, copyright infringement or other claim by any other person or entity. I agree to the terms of this agreement, acknowledge that I am bound by the provisions set forth herein, and recognize this agreement as the entire understanding between the parties with respect to the subject matter hereof.
