Discussion: The water meter at gate is now being billed to us by Gulf Breeze. Ray will insure that we are not being charged for sewer.

Committee Reports:

ACC Committee: Peg Gilmore reported that the Stenicka project had been approved.

Gate Committee - Glenn Barbee reported that new gate operators were installed before the Annual Meeting. We had an initial problem with the bolt attaching the operating arm to the gate coming unscrewed. Review by camera reveals that it was not tampering but simply the nut working loose from repeated operations. Company was notified and they fixed the problem the next day. The only other problem we had was when the Christmas wreath was installed on the gate, the extra weight would make the gate bounce in its closing cycle when it slowed from fast close to ease on shut. The gate would then flex and bounce triggering it to open again, and going into this repeated cycle. Removal of the Wreaths extra weight fixed this problem. Now working great.

Motion: Glenn Barbee moved and Tom Lange seconded that \$500 be approved for road repair and portable camera. Motion carried unanimously.

Gate Beautification/Garden Club – No report

Gate Camera Maintenance – Glenn Barbee reported that cameras were used to attempt to find out who was tampering with the gate only to reveal that no person was responsible, but a gate malfunction. We were able to diagnose problem correctly and get it repaired. Committee finalized a design for installation of third camera that capture the outgoing vehicles tag images. Committee will attempt to install in next few weeks with a good weather day. We purchased an additional portable camera to random mount for detection of various violations going on. i.e. Trucks driving down greenways/drainage areas, or painting or tearing down posted signs.

- A. IIDC property process Brooke Agers reported that we will follow our attorney's recommendation to file liens against the Innerarity Development Company property and let it sit pending litigation.
- B. Tom Lange will coordinate with Cheryl Kelly to work with new owner/builder to provide IIA,Inc input to plans for the property. Glenn Barbee and Ray Moody will assist this effort.
- C. Ray Moody moved and with Leigh Dawkins seconding to authorize \$300 to Shawn's Lawn Care for the removal of a dead tree near the gate. Tri State's bid was \$1,200. The motion passed unanimously.
- D. Tom Lange asked if anything could be done for the standing water near N Shore Rd and N Shore Way intersection. Homeowner building on IP Road was concerned that lack of drainage was due to clogged or overgrowth. We are not responsible. County approved the design, but area does not drain.
- E. Glenn Barbee will research having our meetings at the Innerarity Point Road Fire House. Tom Lange said his house was available if necessary.
- F. Ray Moody reported that Ken Bolton was concerned about vehicles driving on our Greenways. He will get estimates for installing posts to bar such traffic.
- G. Brooke Agers reported that Kyle Roberts had repaired damaged road signs on his own initiative. Ray will contact him about repairing others.
- H. A notation will be placed on our Website directing callers to contact Ethridge Property Management before calling any Board members.

Adjournment: There being no other business, Leigh Dawkins moved and Glenn Barbee seconded that the meeting be adjourned. Motion carried unanimously and meeting was adjourned at 5:10 pm.
