## --Reports of committees

Finance: TB—Went over income statement for end of 2018.

AT: Motion to escalate the collections on those still outstanding more than 90 days on our fees. Seconded by KW. Unanimous. Motion carries.

**Seascape:** RP—All signs deployed, printed, posted. Gates all locked, and code given to ECUA and Gulf Breeze to the sewage pump. It is 100% effective for stopping cars and trucks. Next proposal: Purchase landscaping boulders for less than \$500 to prevent ATVs/golf carts getting into area and causing issues in greenways. Stage Three: About 5 entrances where greenways connect with North Shore Road we will need to block those as well. GF: Motion to provide up to \$500 for barriers. Seconded by AT. Unanimous. Motion carries.

**Architectural Control Committee:** MG—Currently six new homes under construction, three almost complete. Discussion on whether impact fees are reasonable. KW: Motion to create a Grievance Committee, second by GF. Volunteers: Andrea Wralstaad. AT: Move to table motion. Seconded by GF. Unanimous. Motion carries

**Landscape:** GF—Looking at bids for maintaining grass around island. New ones to come. Discussion about sprinkler system working at gate as well as working to repair gate at entrance.

**Covenant and Bylaw Revision Committee:** GW—The verbiage needs to be cleaned up to make sure "developer" and Homeowners are same. Covenants says our responsibility that new buyers receive a copy of the covenants. Etheridge needs to distribute. CK: We cite the website

where those documents are available. GW: Need a way to solicit changes to existing covenants. Dependent on being able to contact all homeowners.

**Entertainment Committee:** Twice yearly yard sale dates spring and fall. AT will propose dates at next meeting.

**Gate:** KW—Complete and works great. Still a piggybacking issue both residents and non-residents, and people coming in the out gate. Dealing with issues. In the process of disabling fobs as we speak.
