Gate area, right of ways, and greenways continue to be maintained by Shawn's lawn care. 2018 contracted costs presented for review.

Discussion of additional speed bump on IPR and N Shore Rd to help control speeding. Terry and Mike to give a proposal for the location of new speed bumps at the Annual meeting.

15 active projects with 3 additional lots being cleared this week. Multiple complaints about work hours of crews; however, crews are working within county approved work hours. ACC working diligently to keep up with condition of active sites.
