These were supposedly long life bulbs so Vann suspects some form of power surge knocked them out. Vann bought a new flag for flag pole since original flag is starting to fray & come a part. Will replace in the next two weeks. Total cost for everything was less than \$50 and Vann will send receipts once new flag arrives.
