I have successfully reigned and completed my reign as an elected Monarch of a member court in good standing.	We believe that successfully completing your year as an elected Monarch is an important experience to help you understand the opportunities and challenges as an official representative of the ICC.
I hold a valid passport allowing travel to all ICS Countries. (Expiration date):	Part of representing the ICC means being able to be present. Further it opens the ability for all Courts to host ICC events.
I have not been convicted of any felonious crime, or any crime that would prevent international travel in my City/State/Province/Country, that will preclude me from travel to any ICS Country.	It takes more than a passport to travel. For example, a DUI conviction in the US means you generally may not enter Canada, same with violence, sex, and drug convictions.
I will immediately step down as an Elected or Regent Monarch, or Board Officer of my affiliated Court Board of Directors, and/or the International Court Council (ICC), if elected as a Titular Head. Are you currently serving in one of these affected positions?	Under California nonprofit law your highest due diligence must be to the organization. Split loyalties or perceived conflicts of interest should be avoided. And frankly, there's lots of work to be done!
I have not served at any time as an elected or anointed Titular Head of the ICC (single term rule).	Aka, the "one and done" rule. We have many potential leaders in our Courts that should have the opportunity to become titular heads.
I understand and agree that I must be in attendance at the nominating meeting and accept the nomination by attestation below.	The nominating meeting/orientation to campaigning will be via Zoom and attendance will be required.
I understand that the position does not include any travel fund and that any requests for attendance at state visits will have to be negotiated with the requesting Court.	This is a significant change that was requested by many Courts and the Council, so we wanted to call it out.
I understand and agree that as a member of Council I am required to pay annual dues of \$1,000.	Many people may not be aware of this Board/Council requirement, so we wanted to specifically call it out.
I have read the Bylaws, and I understand and agree to the transition from an anointed titular head to an elected titular head governed by the Board of Directors.	As a California nonprofit you are expected to know and follow the bylaws, reading them is the first step in that process.
I understand that if elected I may only serve a single term of no longer than five (5) years from the date of ceremonial crowning.	The person elected may state that they only want a 3, 4, or 5 year term. Specificity helps with transition planning and continuity.

Think of this a the "prior employer reference check" on your application.
