NBAFC – Chief Greg Partridge

Many points were brought up at the last meeting. The highlights were:

- Saint John Fire offered HazMat training on Friday evening and Saturday
- Basic Off-Road Rescue Kits are available at a cost of \$4,000
- Maritime Convention 2013 will be hosted in Summerside, PEI and 2014 in Pictou County, NS
- DNR report 80 forest fires with a loss of 4 hectares and 2 air attacks compared to last year; 341 fires with a loss of 360 hectares and 23 air support.
- President's Award will be conducted via NBAFC
- Questions arose about NBPower paying for hydro pole fires, some departments have submitted for remuneration of calls attended.
- Regional dispatch Grand Falls costs \$22,000
- NBCC reps were on-hand for Q&A
- 50/50 draw is setup and payable \$60/year
- January 25-26 is the next scheduled NBAFC meeting
