GUEST SPEAKERS

Brian Brown – OFM NB Firefighter's Peer Support Network Brian brought two (2) service dogs with him. River is an 8-year-old poodle and is Brian's service dog and Napoleon is an 8 month old golden doodle and is new to the program. He let the two dogs roam the room. The service dog is prescribed to you to help de-escalate the situation of stress or PTSD before it gets out of hand. The network has 14 members on the team and can be reached at 1-833-535-3473, there is a fellow firefighter from across the province prepared to take the call French or English 24/7. It's anonymous, they are there to let you say what you need to say, what do you need, (example) someone to go for a coffee with you or accompanies you to a councilor if you don't feel comfortable going alone.

If you want to have a conversation about mental health or stress, Brian can go out to a Fire Department with Napoleon and have him work the room, just give him a call. The link is also on the NBAFC website just look under peer support network, the directory is free for your use. Brian left brochures with another agency called PSP Net - it is an online virtual help system which you can refer to yourself, fill out a questionnaire, chat to a psychologist online, this is free as well. There is another program called Prevail Solutions, you do an online survey, fill in questionnaire once a week, it is reviewed by a psychologist, they reach out and make a phone call to see how you are making out. He brought challenge coins and left a few on the table.

Motion was made that SEFFA will purchase up to 10 seats or \$2,000 for the Mentorship Through Brotherhood Conference being held on October 12 and 13, 2022. One seat per department and their dues must be paid to be eligible to put their department name in the draw. From the 36 departments, 10 departments will be drawn out of a hat. If that department has no one to send, it goes back into the draw and another department will be drawn. The department that has members who want to attend, the Chief will do another draw in their department to see who goes.
