#### **Operation Covid Plans**


Reminder to all Fire Chiefs to ensure their Operation Covid Plans are in place for your members to follow. This is especially important as we face the evolving variant strains of the virus. Most importantly, WSNB have been doing periodic checks and FD's are not exempt from these.

#### **Training**

Several members have expressed frustration over the inability to have their members tested, who are enrolled with NBCC in their FF 1 program.

#### WSNB / Form 67 and FF Compensation

Recently a claim was submitted to WSNB for a Firefighter who was injured. This process was very frustrating for both the individual and Fire Chief. I've had several discussions on the matter with Fire Chief Charlie Kavanaugh, President of the NBAFC. The NBAFC Executive will be meeting to discuss this process next week. I have suggested that an FF/FD Advocate be formed, as well as, a review of the legislation. In addition, presently the NBAFC does not have a Committee formed to deal with matters that may arise. This is an important topic and could affect any member and his/her family.

## NBAFPO – Tim Dryden

## <u>OFM – Raymond LeBlanc</u>

- Auxiliary award finalized. Form will be distributed-people can apply for this award who are not eligible for existing provincial or federal medals.
- Green lights on personal vehicles (Sent out this week-no green lights allowed for personal vehicles)
- Good response on online course delivery. Hoping to expand into fall 2021.
- FIRS system expanded to include insurance company reports (Linked to incident)
- Looking to link FIRS reports to fire incident reports
- Train derailment-Reminder to all chiefs that THEY are the sole responsible party (Not CN, etc).
- Flood planning 2021 (Just a heads up that this will be coming)

## Priority access of vaccines for Family members of Firefighters

- At this time, firefighters (career and volunteer) have been included in New Brunswick as a phase 2 priority vaccine group on the basis that they provide an essential service, and that they have a greater likelihood of infection given the potential for patient contact. Mike Lewis will confirm if the family members of the firefighters will be included as well.
- Decisions on vaccine priorities are made by the department of health by an epidemiologist. I will bring forward your concerns to that group for consideration.
- Ray will confirm if those on WCB or nurses are included for the vaccines as well.

#### **Local Assistant Appointments**

- Our position continues to be that having a Local Assistant appointment remains a benefit to
  municipalities and local service districts by offering provincial indemnification for activities done
  in good faith. We will continue to work with any fire service that wishes to have an
  appointment, the training of which is now offered in an online format. We will accept local
  assistant appointments for any chief or qualified senior designate.
- Mike Lewis will reach out to those departments who have expired in 2020.
- Ray will send Kent additional information on the benefits of having a Local Assistant.

#### **Training and Examinations**

- We recognize that the initial policy of not allowing provincial examinations during orange, red or lockdown phases of New Brunswick's COVID-19 Recovery plan posed challenges to fire departments. Being able to efficiently train and certify firefighters is essential to recruiting and retaining volunteers, and providing a service.
- As a result, earlier this week we distributed an update examination policy that allows for exams. We have committed to clearing the backlog of individuals awaiting exams in a timely manner-even if means bringing on additional proctors or paying for additional sessions to do so.
- We are looking at alternatives so that examinations can continue, even if the province returns to the red phase in the future. Firefighter certification is an important feature of firefighter training, and it is essential that examinations remain impartial.
- For that reason, it is not feasible to consider having fire departments self-administer examinations. If a department needs an examination, we will provide it-even if it means bringing on more proctors or screeners-we have allocated additional funds for this purpose.

## **ATC Report – Daniel Dupuis**

#### Level 1

Due to Covid, we have been doing Level 1 via virtual training. It has been slow going due to exams not being able to get done (red zone), we will be pushing some exams over the next few weeks so students can move to block 2 so hopefully we can get back on schedule. Instructors have been providing theory (only) online with students. Exams will be hosted at NBCC campus with set protocols.

#### Level 2

Sackville has completed their level 2, awaiting review and exam.

Due to Covid, same as level 1, we have been doing online training on Wednesdays, the course is almost completed.

#### **Basic Off-Road Rescue**

Please advise if you have any firefighters interested in doing the course (same drill, online theory only)

#### **Low Angle Rope Rescue**

Please advise if you have any students interested in a new course (same as rest, online only)

#### **Auto Extrication**

We have also had requests for an auto extrication course, again, please advise ATR if you have any firefighters interested in this course, pre-requisites are firefighter level 1 (not enough students at this time) online theory only

#### **Officer and Instructor Courses**

These are also available if we can get enough students for a course online and theory only
