- Fire training survey went out the first week of September
- Fire Prevention Week "Learn the Sounds of Fire Safety". Materials can be purchased through CanOps, Firehall Bookstore (English only) or Prevention Source with Burny. Fire Safety Gazette will be distributed to the schools soon and we urge fire departments to promote it during FPW and remind children to fill out the ballot for a chance to win a prize of Fire Chief for a Day. Draw to be held around November 22nd;
- OFM Fire Department Auxillary Award for those not eligible for a medal but still do important support work for the fire department;
- Upcoming Firefighter Workshop in Miramichi- Sept 11,2021
- Fire Service 2025...Only two departments remaining
- Working on an on-line Fire Investigation Awareness for First Responders presentation that should be available later this Fall/early winter;
- Local Assistant Appointment (new or renewal) course available on-line. Requires criminal record check (within 6mo), application and drivers license approval sheet (can get from you);
- Reminding fire departments that as we are in the green phase, they should still practice social distancing and other precautions when training, meetings or other group functions.
- Our Peer Support Program is nearly ready for launch (most likely end of September). We will have promotional material to give to each of the associations to distribute to depts. Currently the poster and information sheets are being translated and once translated they will be sent off to the Printers. We will also have the information and contact information posted to the NBAFC website as well as the facebook page.

Once we are finalized with the training (scenario training), we will have a soft launch of the network followed by some information sessions led by the peers with their associations and able to go to depts to discuss.
