DUST CONTROL Residential – Commercial Roads, Yards, Lanes

Having problems with road dust at your home or business? Freeborn County Coop Oil is offering dust control service. This spring, we will begin applying magnesium chloride to graveled surfaces for residential and commercial customers. In most cases, we will make 2 applications – 1 in the spring, and the other in mid or late summer. Other scenarios, to fit your needs, might include 1 application, or 3 or more.

Magnesium Chloride is an environmentally friendly product that is applied to graveled surfaces in liquid form. It bonds with gravel particles, creating a coating that absorbs moisture from rain, dew, etc. This gives the gravel a wet look even though it's dry. When magnesium chloride is first applied, it is mildly corrosive to metals until it has dried. Usually, it is dry for approximately one hour. Rain will not reactivate the corrosiveness. In areas where there is concentrated product run-off during application, injury to grass and plants may occur.

Due to unpredictable conditions, the duration of product life is **NOT GUARANTEED**. Extremely heavy traffic, hot, dry, windy weather or heavy rain will diminish the product effectiveness. Subsequent applications from year-to-year increase product effectiveness. It is not always total dust elimination, but as it says, dust control. This product has proven very successful in controlling dust problems.
