- Any delivery, set up and clean up of lighting, floral or other décor elements must occur during your contracted rental period.
- Base table linens in choice of color for up to 15 tables are included. Additional quantity and rental options available at additional charge.
- Tables, chairs and audio-visual systems are included in the rental price.
- PROHIBITED ITEMS: sparklers, any open flame not contained, paper lanterns with flames, helium balloons, rice, glitter, confetti, silly string, potpourri, and bird seed. Nails, tacks, tape and command strips etc. may not be used anywhere at the venue. Client will be charged for all damages incurred.
- Only registered service animals permitted in event space without previous written consent. Service animals

• are those expressly trained to perform a task directly related to a person's disability.

- Patrons and their guests must act in a civilized manner while at the venue. We reserve the right to remove persons from the premises for behavior that management considers objectionable. Patron and their guests are restricted to the building and grounds that they have rented. Patron and their guests are responsible for the safety and supervision of their children.
