A special meeting of the Board of Town Trustees of the Town of Norwood Park was held at the Town Hall, 7833 West Lawrence Avenue, Norridge, Illinois, on the 25th day of April 2025 following the public hearing on the Budget and Appropriation Ordinance of the Highway Commissioner.

The meeting was called to order by ANTHONY NASCA, Town Supervisor, on said date, and the following occurred:

There was also present at the said meeting the Highway Commissioner PAUL ALONGI and the Town Attorney, JOHN D. SPINA.

The Town Clerk, Eve Pokorny, acted as Clerk of the meeting.

The reading of the Minutes of the previous meeting of the Board of Town Trustees was waived on motion of Trustee Stefanowicz, and seconded by Trustee Wyda, and said motion unanimously carried.

The Supervisor advised that the first order of business was to approve the Norwood Park Township Road District Tentative Budget and Appropriation Ordinance for the fiscal year beginning April 1, 2025, and ending March 31, 2026. The Supervisor further reported that a public hearing had been held concerning said Budget for the fiscal year 2025-2026 earlier, to wit, April 25, 2025, at 6:15 p.m., which Budget was unanimously recommended to be approved as submitted, totaling: \$203,366.00 for the Road and Bridge Fund; and those said appropriations be approved in all respects.

It was moved by Trustee Stefanowicz, Jr., and seconded by Trustee Wyda, that the Norwood Park Road District Budget and Appropriation Ordinance for the fiscal year commencing April 1, 2025, and ending March 31, 2026, and which had been recommended


to be approved by the Town Electors at a public hearing on April 25, 2025, which appropriated \$203,366.00 for Road and Bridge be approved in all respects. A copy of such Budget and Appropriation Ordinance is attached hereto and made a part hereof as though fully set forth herein and marked as Exhibit A.


At this time the Supervisor asked those members of the public in attendance if there was any public comment on the proposed budget. No member the public offered any question or comment. The Supervisor closed public comments.
