### **Supervisor's Report:**

Supervisor Nasca reported the following:

There are two ongoing G.A. cases and none pending.

The digital sign has been approved by the village, is being built, and will be installed in early December.

There is a new entry sign to reflect current officials.

November 5<sup>th</sup>, Election Day was busy with at times around 25 residents waiting to vote. There was a steady stream of voters, around 400 throughout the day including 44 newly registered.

Trustee Di Piero moved, seconded by Trustee Stefanowicz to transfer \$10,000 from Road and Bridge 2024/2025 budget line item, engineering to Road & Bridge 2024/2025 budget line item, maintenance for roads. Supervisor Nasca called for a voice vote. Motion unanimously carried.

**New Business:**

Trustee Stefanowicz moved, seconded by Trustee Di Piero, to approve the Annual FOIA Ordinance. Supervisor Nasca called for a voice vote. Motion unanimously carried

**Assessor's Report:**

Assessor Karns stated there was nothing to report since the last meeting and that will remain the case probably until the new year when the 2024 exemptions are available.

**Highway Commissioner's Report:**

Highway Commissioner Alongi reported that since the recent snowfall melted there was no need for plowing or salting. He added the pothole repairs have been completed.


