Approval of Minutes from November 21, 2025, Town Board Meeting

As the first order of business Supervisor Nasca entertained a motion to dispense with the reading of the minutes of the November 21, 2025, Town Board Meeting and accept them as presented. Trustee Wyda moved. Trustee Stefanowicz seconded the motion. Supervisor Nasca called for a voice vote. Motion unanimously carried.

Approval of Expenditures for Town Fund, Road & Bridge and General Assistance

Trustee Cichon moved, seconded by Trustee Di Piero, to authorize the expenditures for the Town Fund, Road & Bridge and General Assistance. Supervisor Nasca called for a voice vote. Motion unanimously carried.

Public Comment:

Cook County Sheriff Police Commander Busching addressed the Board sharing information about Illinois State surplus programs. She also reported updates regarding the current speed enforcement program being implemented in Norwood Park Township and neighboring communities.

Supervisor's Report:

Supervisor Nasca stated the following:

There is one ongoing GA case and none pending.

The donations collected by the Township were delivered to the "Toys for Tots" Northbrook facility on December 11.

About 15 residents were in attendance for the Cook County Sheriff's presentation "The Sweetheart Scam" which was held at the Township on December 15. In addition to the presentation that day a Representative from the Clerk of the Circuit Court of Cook County was here to share information with residents on functions and services available from their office.

"Cards and Crafts with Michelle" was held at the Township on December 10. The next class will be held on January 8, 2026.

Committee Reports:

Trustee Di Piero (Building Maintenance & Veterans Committee) stated he had nothing to report at this time.

Trustee Wyda (Senior Citizens & Disability Committee) reported that 0 cab books were sold in December.

Trustee Cichon (Youth Committee, Law and Ordinance) stated he had nothing to report at this time.

Trustee Stefanowicz (Finances) reported that since last month's meeting was held earlier than usual, he had just reviewed the November financials in which all was good. The December report will be reviewed in January.

Assessor's Report:

Assessor Karns relayed the following:

The window for appeals has ended. The 1st installment for 2025 property taxes will be due on April 1, 2026. The Township will be very busy this summer assisting residents with concerns regarding assessments.

Highway Commissioner's Report:

Highway Commissioner Alongi reported the following:

The plowing in the unincorporated area went very well with only a few minor complaints from residents. There is a need to remedy the action of residents blowing or shoveling snow onto already plowed streets causing ice pockets. In addition, an ordinance or program might need to be implemented to keep resident vehicles off the street until post snowfall plowing is completed.


