Supervisor's Report:

Supervisor Nasca reported the following:

There is one ongoing GA case and none pending.

Assessor Karns attended the Cook County Board of Review presentation held at Ridgewood High School on August 14th.

There was a Cook County Analyst at the Township on August 15 to assist residents with filing their property assessment appeal. Around 30 residents came in that day to utilize that service.

Despite the drizzly weather, there was a good turnout for The National Night Out held on August 6th.

The Township will be hosting the following upcoming seminars:

September 24th at 1:00 p.m. Dietician Lydia Nader with Fuel up Performance Nutrition will be returning with a presentation on the "Unknown Macronutrient".

Assessor Karns on October 9th at 7:00 will be hosting a seminar regarding searching for comparable properties when filing property assessment appeals.

The Cook County Sheriff's Department will be providing a presentation titled "Holiday Safety/Online & Cyber Security" at the Township on November 26th at 1:00p p.m.

The Township is waiting for a date in early December to schedule a self-defense class for residents with the Cook County Sheriff's Community Engagement Officer.

New Business:

Supervisor Nasca and the Board discussed the options for providing a Chess Camp for resident youth. The Youth Committee will meet in September to vote on the matter and bring before the Board.

Committee Reports:

Trustee Wyda (Senior Citizens & Disability Committee) reported there were 2 taxi-cab books sold in August.

Trustee Cichon stated there is nothing to report for Youth Committee, Law & Ordinance.

Assessor's Report:

Assessor Karns reported the time for residents of Norwood Park Township to appeal their property assessments with the Board of Review ended on August 20th. He stated that over 100 residents filed appeals at the program that was held at Ridgewood High School. The next day, 30 more residents came to the Township to file an appeal with the Cook County Analyst. Assessor Karns added that next year is a reassessment year so there will be many residents coming into the office for assistance with appeals.
