# Approval of Expenditures for Town Fund, Road & Bridge and General Assistance

Trustee Wyda moved, seconded by Trustee Di Piero, to authorize the expenditures for the Town Fund, Road & Bridge and General Assistance. Supervisor Nasca called for a voice vote. Motion unanimously carried.

### Supervisor's Report:

Supervisor Nasca stated the following:

There is one ongoing GA case and none pending.

The Township received a complaint about overgrown grass and miscellaneous debris on the exterior of a property located in the 5400 block of Linden Ave. A notice from the Township was posted on the property. The Township contacted the Cook County Building Department who inspected the property and cited numerous violations.

On August 11th a construction crew hit a water main feed in Unincorporated Norwood Park Township near the corner of Bryn Mawr and Courtland which caused a large geyser.

On August 21st Michelle conducted another "Crafts and Cards" class.

The "National Night Out" was held on August 5<sup>th</sup>. A letter was received from the Norridge Police Department thanking the Township for its contribution and support. Supervisor Nasca additionally thanked Highway Commissioner Alongi, Trustee Cichon, and Clerk Pokorny, along with her husband Jim, for volunteering for the event.

A letter was received from School Districts 80, 79, and 86 in appreciation of and thanking the Township for its support of this year's Norwood Park Township Summer Enrichment Camp.

The Ridgewood Girl's Basketball Team sent a letter of thanks to the Township for the grant the team received.

### **Committee Reports:**

Trustee Di Piero (Building Maintenance & Veterans Committee) stated there was nothing to report at his time.

Trustee Wyda (Senior Citizens & Disability Committee) reported 0 cab books were sold in the month of August. He also reported on the Senior Citizens Committee Meeting held earlier in the evening where the committee voted to recommend that The Township Board approve The Township enter into the contract with Aging Care Connections allocating up to \$30,000 annually as the budget allows for a five-year term benefiting Township senior and disabled residents.

Trustee Cichon (Youth Committe, Law and Ordinance) stated there was nothing to report at this time.

Trustee Stefanowicz (Finances) stated that according to the July 31, 2025, financial statements, all is good.

#### **New Business:**

The Board took no action on a grant for the Senior Assistance Center.

As the Senior Assistance Center is merging with Aging Care Connections, Trustee Stefanowicz made a motion to approve Norwood Park Township enter a five-year Social Services Contract with Aging Care Connections in which The Township would agree to contribute up to \$30,000 annually, conditioned on the Township obtaining appropriated funding, to Aging Care Connections who in turn would provide services benefiting Norwood Park Township senior and disabled residents. This motion was seconded by Trustee Cichon. Supervisor Nasca called for a voice vote. Motion unanimously carried.

### **Assessor's Report:**

Assessor Karns relayed the following:

The Board of Review property assessment appeals ended August 5<sup>th</sup> with decisions likely coming out in late September. There is still no word from Cook County when the 2<sup>nd</sup> installment property tax bills will be sent out.

## **Highway Commissioner's Report:**

Highway Commissioner Alongi stated cement work in Unincorporated Norwood Park Township addressing emergency trip hazards is being done. He also reported the 2025-2028 snow plowing bid has been accepted.
