A special meeting of the Board of Town Trustees of the Town of Norwood Park was held at the Town Hall, 7833 West Lawrence Avenue, Norridge, Illinois, on the 26th day of April, 2024 following the public hearing on the Budget and Appropriation Ordinance of the Highway Commissioner.

The reading of the Minutes of the previous meeting of the Board of Town Trustees was waived on motion of Trustee Alongi, and seconded by Trustee Wyda, and said motion unanimously carried.

The Supervisor advised that the first order of business was to approve the Norwood Park Township Road District Tentative Budget and Appropriation Ordinance for the fiscal year beginning April 1, 2024, and ending March 31, 2025. The Supervisor further reported that a public hearing had been held concerning said Budget for the fiscal year 2024-2025 earlier, to wit, April 26, 2024, at 6:15 p.m., which Budget was unanimously recommended to be approved as submitted, totaling: \$141,266.00 for the Road and Bridge Fund; and that said appropriations be approved in all respects.




