Supervisor Nasca called the meeting to order at 6:45 p.m.

As the first order of business Supervisor Nasca entertained a motion to dispense with the reading of the minutes of March 22, 2024, and April 9, 2024 (Annual Town Meeting) and accept them as presented. Trustee Wyda moved. Trustee Alongi seconded the motion. Supervisor Nasca called for a voice vote. Motion unanimously carried.

Trustee Cichon moved, seconded by Trustee Wyda to authorize the expenditures for the Town Fund, Road & Bridge, and G.A. Supervisor Nasca called for a voice vote. Motion unanimously carried.

Supervisor's Report:

Supervisor Nasca informed the Board of the following:

There is one ongoing G.A. case and none pending.

The second property tax workshop was held on April 25th. There was a great turnout comprised of around 25 residents. The emailed surveys returned by attendees were positive.

On April 16th, the Cook County Sheriff along with the Township hosted the first in a series of safety presentations. The event was well received by the 24 residents who attended. The next presentation in the series is tentatively scheduled for June 25th at 1:00. It will be the "Money Smart for Older Adults Program" which raises awareness among older adults and their caregivers on how to prevent fraud, scams, and other elder financial exploitation.

Community Kindness Day took place this past Saturday (April 20). The staff along with the Supervisor were at the Township that day to collect food and toiletry donations for the Salvation Army Citadel Norridge. The supervisor thanked Heidi, Fiona and Fiona's son Brian for assisting in sorting, packing and delivering the donated items.

Committee Reports:

Trustee Alongi stated all is okay regarding building maintenance and he has not received any complaints.

Trustee Wyda reported there were 0 taxicab books sold in April.

Trustee Cichon stated there is nothing to report for the Youth Committee this month.

Trustee Stefanowicz reported all is stable with the finances and the Budget Hearing.

Trustee Alongi moved, seconded by Trustee Cichon, to approve funding of \$5,500 for the 2024 Norridge and Harwood Heights National Night Out. Supervisor Nasca called for a voice vote. Motion unanimously carried.

Assessor Karns stated the time to file an Assessment Appeal in Norwood Park Township ended on April 5th. He added the Property Tax Exemption filing deadline is April 29th. Any property owner that does not meet that deadline to file an exemption will instead need to file a Certificate of Error,
