As the first order of business Supervisor Lupo entertained a motion to dispense with the reading of the minutes of March 31, 2023 and accept them as presented. Trustee Wyda moved. Trustee Alongi seconded the motion to dispense with the reading of the minutes of March 31, 2023.

Trustee Nasca moved, seconded by Trustee Stefanowicz, to authorize the expenditures for the Town Fund, Road & Bridge and G.A. Supervisor Lupo called for a voice vote. Motion unanimously carried.

The Decennial Committee discussion was tabled for the time being and will be reopened at the May 26 meeting.

Clerk Salinsky appointed Fiona Tanny as Deputy Clerk. Trustee Wyda moved, Trustee Alongi seconded, and Supervisor Lupo called for a voice vote. Motion unanimously carried.

Trustee Alongi has the flag and banner for the Norridge 75<sup>th</sup> Anniversary. More will be discussed on this event by the board at a later date.

**New Business:**

The Norwood Park Township will be represented in the Memorial Day Celebration held in Norridge by Trustee Nasca and Trustee Alongi.

The Annual Budget meetings for the Town Fund, General Assistance, and Road & Bridge were held shortly before this April 28<sup>th</sup> meeting. All three budgets for the 2023/2024 fiscal year were passed.

**Assessors Report:**

Assessor Karns informed the Town Board that the time for filing property assessment appeals has now ended. He also stated that homeowner exemptions can still be filed until May 10. Assessor Karns also reported that in the last few weeks more than a hundred residents have come into the Township office seeking assistance with their property appeals and exemptions.

**Highway Commissioner's Report:**

Commissioner Rogawski informed the Town Board that pothole season is upon us. Several requests have come in and have been taken care of.

Redwood and Rascher water supply repairs were completed and the street repair estimate was provided.

Potential permit/repair escrow ordinances regarding private sector street openings and repairs are currently under review.

The Highway Department budget was passed as presented.
