Supervisor's Report:

Supervisor Nasca informed the Board of the following:

There is one ongoing General Assistance case and none pending.

The Township hosted a Property Tax Workshop on July 11th. There were two Cook County Analysts present assisting attendees with property assessment appeals. The feedback from attendees was positive.

A Cook County analyst is scheduled to be at the Township on August 15th from 10:00 a.m. to 2:00 p.m. to assist residents with property tax appeals.

On July 16th after the storms the Township received a few calls from residents of the unincorporated area regarding downed trees. These were investigated by the Supervisor.

On July 16th it was discovered the outside electronic sign received damage. Originally thought to be from the storms, it was later determined by Paldo signs to be the result of being struck by a large vehicle. A police report has been filed and a claim made to the insurance company.

Lydia Nader of Fuel Up Nutrition presented a healthy eating seminar to residents at the Township on July 23rd. It went very well. There were 15 attendees.

The Norwood Park Township Summer Enrichment Program started Monday July 15th and ended on July 26th. This year there were 192 children of all grades participating.

The office copier went down last week. Last year, when it was repaired, the serviceperson said the company would no longer be able to support the outdated machine and software updates were no longer available. The Township purchased a new printer/scanner which so far is working well.

Committee Reports:

Trustee Alongi (Building Maintenance & Veterans Committee) stated the Supervisor covered the issues with the electronic sign in his report.

Trustee Wyda (Senior Citizens & Disability Committee) reported there were 0 taxi-cab books sold in July.

Trustee Stefanowicz (Finances) stated after reviewing the statements from June 30, 2024 all is in order and the Township is financially stable.

In addition, there will be a Cook County Analyst available at the Township on August 15th from 10:00 a.m.to 2:00 p.m. to assist residents with their appeals.
