Supervisor's Report:

Supervisor Nasca informed the Board of the following:

There are two ongoing G.A. cases and none pending.

The second safety presentation hosted by The Cook County Sheriff's Office and Norwood Park Township was on June 25. The event was positive with a good turnout of residents.

The 3rd Property Tax Workshop hosted by Assessor Karns will be held at the Township on July 11th at 7:00 p.m.

The Township will be hosting a nutrition seminar on July 23rd at 1:00 p.m. and will be presented by Lydia Nader of "Fuel Up Nutrition"

The Township has received a few calls from residents in the unincorporated area regarding overgrown vegetation, downed trees, etc. Each of the issues were responded to and handled accordingly.

At the Norwood Park Township Special Meeting held on June 18, Eve Pokorny, resident of Harwood Heights, was appointed and sworn in as the Norwood Park Township Clerk filling the vacancy left by the passing of Frances Salinsky.

Committee Reports:

Trustee Alongi (Building Maintenance & Veterans Committee) stated everything is good and there are no problems regarding building maintenance.

Trustee Wyda (Senior Citizens & Disability Committee) reported there were 0 taxi-cab books sold in June.

Trustee Cichon (Youth Committee, Law and Ordinance) reported on the Youth Committee Meeting held earlier in which an amount not to exceed \$900 was recommended to be granted to fund payment of face painters at the September 7th Battle of the Badges Event.

Trustee Stefanowicz (Finances) stated after reviewing the statements from May 31, 2024 and the letter from the auditor that all is good.

Old Business:

Trustee Alongi moved, seconded by Trustee Stefanowicz to grant an amount not to exceed \$900 for the cost of face painters for the Battle of the Badges Event. Supervisor Nasca called for a voice vote. Motion unanimously carried.

Assessor's Report:
