A special meeting of the Board of Town Trustees of the Town of Norwood Park was held at the Town Hall, 7833 West Lawrence Avenue, Norridge, Illinois, on the 25<sup>th</sup> day of April, 2025.

The meeting was called to order by Anthony Nasca, Town Supervisor following the public hearing on the budget and appropriations ordinance, on said date, and the following occurred:

The Supervisor advised that the first order of business was to approve the Town of Norwood Park Tentative Budget and Appropriation Ordinance for the fiscal year beginning April 1, 2025, and ending March 31, 2026. The Supervisor further reported that a public hearing had been held concerning said Budget for the fiscal year 2025-2026 earlier, to wit, April 25, 2025, at 6:40 p.m., which Budget was unanimously recommended to be approved as submitted, totaling: \$89,400.00 for the General Assistance Fund; and those said appropriations be approved in all respects.

It was moved by Trustee Frank DiPiero and seconded by Trustee Dennis Stefanowicz, both Town Trustees, that the Norwood Park Budget and Appropriation Ordinance for the fiscal year commencing April 1, 2025, and ending March 31, 2026, and which had been recommended to be approved by the Town Trustees at a public hearing at 6:40 p.m. on April 25, 2025, which appropriated \$89,400.00 for General Assistance be approved in all respects. A copy of such Budget and Appropriation Ordinance is attached hereto and made a part hereof as though fully set forth herein .
