Supervisor's Report:

Supervisor Nasca reported the following:

There are two ongoing GA cases and none pending.

The following activities were held at the Township in January. The chess camp held on January 3rd had 12 attendees and went very well. Dietician nutritionist Lydia Nadar presented "Nutrients to Help Power the Brain" to 24 residents on January 16th.

On January 7th, the Supervisor met with the Senior Assistance Center Board and presidents of Norridge and Harwood Heights to discuss The Senior Center's partnership with Aging Care Connections.

The Supervisor also met with Eisenhower Library's Norwood Community Connections Committe on January 27. On January 29th Highway Commissioner Alongi, Trustee Cichon and Supervisor Nasca attended the open house and ribbon cutting for Penoyer School. The Supervisor relayed that a fantastic job was done on the school's addition and the teachers and parents were very proud.

The Township Officials of Illinois is sponsoring its 43rd Annual Township Lobby Day in Springfield on April 28th, 2025.

The Supervisor is still investigating having the Township attend the Health Fair at Eisenhower Library on May 10^{th} .

Trustee Stefanowicz followed up the report with a question regarding GA documentation. Supervisor Nasca confirmed all documentation was current and updated monthly.

Assessor's Report:

Assessor Karns stated the 1st installment payments of the 2024 tax bills are out. He will be attending another meeting in late March or early April regarding the proposed assessments.
