As the first order of business Supervisor Lupo entertained a motion to approve the minutes of August 26, 2022 Board Meeting. Trustee Wyda moved, seconded by Trustee Nasca, which the reading of the minutes of the August 26, 2022 minutes be waived and that said minutes be approved as presented. Supervisor Lupo called for a voice vote. Motion unanimously carried.

Trustee Nasca moved, seconded by Trustee Alongi, to authorize the expenditures for the Town Fund, Road & Bridge and G.A. Supervisor Lupo called for a voice vote. Motion unanimously carried.

Supervisor Lupo informed the Town Board we have no G.A. cases and have one pending.

Supervisor Lupo also informed the Town Board that there was a broken fire hydrant in the unincorporated area on Bryn Mawr & Fairview. Chicago has been notified.

**Committee Reports:**

Trustee Alongi informed the Town Board that John Soto came out and sealed the roof for the year.

Trustee Wyda reported 9 cab books were sold for the month of Sept.

Trustee Nasca received a plaque for the township from the Jr. Rebels.

### **Old Business:**

Supervisor Lupo and the Town Board discussed and took final action on signs to be mailed to the unincorporated area. Trustee Wyda moved, Trustee Alongi seconded to approve window signs for 399 homes at a cost of \$285.60 to mail. Supervisor Lupo called for a voice vote. Motion unanimously carried.

Supervisor Lupo and the Town Board discussed and took final action for the installation of a prescription drop box. Trustee Wyda moved, Trustee Alongi seconded for the Cook County Sheriffs office to install a prescription drop box in the town hall. Supervisor Lupo called for a voice vote. Motion unanimously carried.

Supervisor Lupo discussed sponsoring the Flu shots this year for the township. Trustee Nasca moved, Trustee Alongi seconded to sponsor the Flu shot but not to exceed \$15,000.00. Supervisor Lupo called for a voice vote. Motion unanimously carried.

Trustee Nasca informed the Town Board of the Youth Committee Meeting for district 80 Cross Country. Trustee Alongi moved, Trustee Wyda seconded to approve and take final action for \$2,500.00 for Dist. 80 Cross Country Team. Supervisor Lupo called for a voice vote. Motion unanimously carried.

### **New Business:**

Supervisor Lupo and the Town Board discussed the Tax Levy for 2022/2023. The Tax Levy will be passed on the November 25, 2022 meeting.

Supervisor Lupo received a grant request from the Senior Assistance Center for their Fall Food Festival Oct. 16, 2022. Trustee Alongi moved, Trustee Wyda seconded to grant \$200.00 for food to the Senior Assistance center. Supervisor Lupo called for a voice vote. Motion unanimously carried.

### **Assessor's Report:**

### **Highway Commissioner's Report:**

Commissioner Rogawski informed the Town he received a call regarding a leaking fire hydrant on Bryn Mawr & Fairview. After determining it was not part of Illinois American Water's system, Superintendent Lupo was able to get Chicago to shut it off & begin repairs.

There were no more pot hole calls. Some residents on Summerdale were inquiring about getting their street repaved. I explained my budgetary constraints and haven't heard

back.

The final phase of the Bryn Mawr sewer project is well under way now that the local 150 Operators strike has been settled. The digging, piping and backfilling should be completed by next Friday if the weather holds. Resodding is also to begin soon thereafter.

Finally, an RFB for a new plowing and salting contract for the unincorporated area has been sent to the newspaper for publishing. Bid opening is scheduled for late October.
