**Supervisor's Report:**

Supervisor Nasca reported the following:

There are two ongoing G.A. cases and none pending.

The Cook County Sheriff's Office presented the Holiday Safety/Online & Cyber Security seminar on November 26 with 22 residents in attendance.

Cook County Sheriff's Office also hosted a self-defense class at the Township on December 11. NBC News reported on the seminar. There is a clip from the news report on the Township website.

This year was another success for the Township Toys for Tots Toy Drive. The Township thanks Fiona and Heidi for organizing the toy drive and Trustee Cichon for his assistance delivering the donations.

The Township joined Eisenhower Library's community mental health committee meeting on December 16<sup>th</sup> via Zoom. This group will be meeting again in January and Supervisor Nasca will report their progress to The Board.

The Supervisor will be meeting with the chair of SAC Board of Directors in January.

The new electronic sign has been installed and the staff trained in the new software.

Upcoming seminars include the Chess Camp on January 3<sup>rd</sup> and Nutrition Program on January 16<sup>th</sup>.

The Township was closed on December 24<sup>th</sup> and 25<sup>th</sup> and will be closed January 1<sup>st</sup>.

The Supervisor is still looking into the Library's Health Fair on May 10<sup>th</sup>.

**Committee Reports:**

Trustee Di Piero (Building Maintenance & Veterans Committee) stated the new digital sign looks good and everything else regarding building maintenance is good.

Trustee Wyda (Senior Citizens & Disability Committee) reported on the earlier Senior Citizens Committee Meeting. They are recommending a grant amount be approved by the Township Board for the Harwood Heights Senior Club in the amount of \$2,000. He also stated there were 0 cab books sold in the month of December.

Trustee Nasca reported on the earlier meeting held by the Youth Committee. They are recommending a grant be approved by the Town Board for the Ridgewood High School Boys Basketball Team in an amount not to exceed \$1,920.00 for team fleece hoodies.

Trustee Stefanowicz reported everything looks in order up to November 30<sup>th</sup> and grant amounts will be reflected at year end.

**New Business:**

Trustee Wyda moved, seconded by Trustee Di Piero, to grant \$2,000 to the Harwood Heights Senior Club. Supervisor Nasca called for a voice vote. Motion unanimously carried.

Trustee Stefanowicz moved, seconded by Trustee Di Piero, to grant an amount not to exceed \$1,920 to the Ridgewood High School Boys Basketball Team. Trustee Nasca called for a voice vote. Motion unanimously carried.
