Disclaimer – Full payment is due 5-7 days prior to scheduled wedding date. If someone decides at the last minute they don't want their makeup done, the bride/attendant is responsible to pay in full to the makeup artist for the inconvenience. Prices & contract is

subject to change at anytime due to inflation. Once Bride signs the contract, they're locked into the price per the agreement. Bridesmaids are not. I thank you for understanding my terms of agreement!

- ☐ I understand that the Makeup Artist needs to be paid in full 5-7 days prior to scheduled date unless spoken otherwise, by the time they leave the venue
- ☐ I understand that AFTER the trial if I need to cancel the Makeup Artist I will do so within 30 Days of wedding date
- ☐ I understand the Makeup Artist charges a Travel Fee of \$1 per Mile
- ☐ I understand that in order for the Makeup Artist to travel there is a 3 person minimum for Makeup for regular pricing
- ☐ I understand for MUA to travel under the 3 person limit for makeup there will be an added \$30 charge to the travel fee
 - o I understand that prior to the scheduled wedding day, we have established a schedule atleast. 30 days prior and if someone backs out last minute for makeup that person will still be charged the full amount

Prices & Payment:

Total Investment - Bride \$300 and that includes False Lashes, Makeup (at both trial and wedding day), Lipstick of their choosing and Beauty Blender, mini touchup kit (price is including booking fee). Total breakdown – 2 hour+ trial \$150. Day of makeup \$120. Booking fee \$30. Booking fee is due at the time of booking, trial fee is due at the end of

the scheduled trial and Day of payment due 5-7 days prior to scheduled wedding date.

Re-Trial \$100

Singular Brides with no bridal party makeup – pricing stays the same except there will be an added \$30 charge to the travel fee. Stated above

Bridesmaids & Attendants \$110 & that includes beauty sponge & false lash application & touch up kit

Attendants who don't want makeup but want false lash application \$15

Travel Fee \$1 per Mile (there and back)

My Payment options are Cash, Venmo , Card Payment – 3% tax for all CC transactions through GlossGenius.

Bride - Upon booking the wedding date there is a \$30 booking fee (non-refundable) to hold the date until the trial along with the signed contract. Trial fee is due at the end of the scheduled trial date and the remainder of the cost is due 5-7 days prior to scheduled wedding date.

Attendants/Bridesmaids -

I require full payment 5-7 days prior to scheduled wedding.
Nonrefundable.

Cancellation Policy:

Cancellation without at least a 30 day written notice will be subject to a cancellation fee equal to the full amount of the signed and executed contract.

Assistants/Other Artists :

If the number of persons needing makeup exceeds 5-6(including bride), OR the timeline doesn't match up where Tara cannot finish all 5-6 in a timely manner then I will require an assistant OR the Bride is responsible to hiring another makeup artist for the remaining individuals that need makeup.

Payment: I will pay the assistant after we finish makeup for the day.
\$30 per hour + tips - I will provide all the makeup unless discussed otherwise. All payments will go to me & will pay the assistant accordingly. This is not an extra charge for the bride!

Hygiene:

All of the Makeup being used is sanitized with Alcohol before and after each use. Disposable applicators are used and there is no doubledipping. I sanitize my hands after each person. 1 time use sponges for each person and that sponge is yours to keep after! If you have any questions or concerns this is the time to ask away! By signing this you understand all my rules and regulations. I thank you so much for your understanding and I am so excited to be a part of your big day! <3
