### President's Report:

Wendy Westock,

<u>Kim Pelayo, Garda Security</u>: Reminder: There are lots of deer, especially by Wild Meadow and Overlook area.

### **Questions from the Residents:**

<u>Resident</u>: Plow Company is doing a great job. I live on a cul-de-sac. I asked one of the drivers if they could plow the snow towards the woods. The driver said "No". He could not plow past the pavement. He said he does not block driveway. I live on Pumice Court.

<u>Amy Panetta</u>: So, there is a couple of things, the plow company and the drivers, they're not going to take request from residents. Only because there's 1100 people saying push it here, push it here. If anybody has an issue, please call the office. We keep a log and update when anybody calls. The drivers keep a log with them. The owner and John from maintenance will go and look at situation.

Wendy Westock: Call the office

<u>Resident</u>: Kim Curulli has a great idea having a beautification committee. I think that is a wonderful thing, but we better beautify some of the places around here. If she is going into all this work and make the office and front look nice. You ride down the road a little bit there is one on the right and one on the left. He is adding more and more cars. I'm sure this is not the only place.

Wendy Westock: maybe out of this committee some suggestions will come from people.

<u>Resident</u>: How to handle those people?

<u>Wendy Westock</u>: Well, the thing is there is nothing in our rules. : It doesn't say anything about how many cars you can have.

<u>Resident</u>: There is... but there is... It doesn't say how many cars, but it does have in our rules what to do if there is a problem, we have that in our rules.

Wendy Westock: I'm not disagreeing with you.

<u>Chuck Roberts</u>: The town has the same problem. The town rules about vehicles got thrown out of court in Lackawaxen.

<u>Resident</u>: A neighbor called about a property, Chris Woods from Milford Township came over and said clean up your property or you will get a \$1000.00 fine. I can't call...

<u>Wendy Westock</u>: Yes, you can, they want to hear directly from the residents not the SLPOA. We are trying to get these situations taken care of. It is frustrating for all of us.

Further discussion with residents and board.

<u>Resident</u>: I'm amazed that he said that he would fine them until they cleaned up because, we have complained about a house on the corner of Wild Meadow and High Meadow. It was a horrible mess. It had huge holes in the yard filled with water. I got a letter saying the holes weren't deep enough. Chris Woods went over there and did nothing. I was wondering if he is selective in what he does.

<u>Amy Panetta</u>: We had a situation with an above ground pool that for two and half years was not maintained. There was water in it, no filter running, and no chemicals put in. The neighbors were begging and pleading with us because they were getting eaten alive by mosquitos. We contacted the township and they said there was nothing they could or would do.

<u>Wendy Westock</u>: We contacted the health department about what we saw as a health issue. They said there was nothing that they could do. They respond better to individual residents.

Resident: Regarding pools, we shouldn't have any pools in our yard. right?

Amy Panetta: No, we can have pools in Sunrise, if you follow township regulations.

<u>Wendy Westock</u>: You have to have a township permit, but Sunrise doesn't have a rule about pools.

Amy Panetta: Yes, discusses pool requirements to residents.

Discussion amongst residents

<u>Wendy Westock</u>: If you see a fire call the fire department and remember you must call the communication center before you burn. It is a rule.

<u>Resident</u>: Were the expenditures just passed for this fiscal year.

Wendy Westock: Yes, budget runs from June 1<sup>st</sup> to May 31<sup>st</sup>.

<u>Resident</u>: How are we doing with the budget.

Wendy Westock: We are in good shape.

<u>Wendy Westock</u>: Plow contract was higher than we had budgeted because the prior company terminated the contract in August, so we had to put contract out for bid. The new contract is 18,000.00 higher than the old one but it covers 5 months instead of 4.5 months.

Discussion of what happens during a storm.

<u>Wendy Westock</u>: We let the community know via email blast and SLPOA Facebook page when there is information about the storm or emergency preparations, and we encourage people to call the office immediately if there is a problem.

<u>Amy Panetta</u>: During the storm we check phones frequently even overnight so we can stay on top of situations and we communicate with the plow company continuously.

<u>Resident</u>: Is the contract per snowfall?

Wendy Westock: No, per year, and this company has been terrific.

Amy Panetta: The price of contract includes sweeping the material at the end of the season.

Wendy Westock asks for a motion to close the meeting at 7:35 p.m.
